Purpose

Preamble

The Oregon-Southern Washington Chapter (OSWAPIC) of the Association for Professionals in Infection Control and Epidemiology, Inc. (APIC) operates under the comprehensive privacy and terms guidelines established by the national APIC organization.

Policy/Procedure

1. Governing Documents

All OSWAPIC chapter activities, website usage, and member interactions are subject to and governed by:

- APIC National Terms and Conditions
- APIC National Privacy Policy
- OSWAPIC Chapter Bylaws

In the event of any conflict between this chapter-level policy and the national APIC policies, the APIC National policies shall take precedence.

2. Membership and Data Collection

2.1 Membership Requirements

- Membership is mandatory for chapter participation [APIC Chapter Bylaws]
- Personal data collection follows APIC's strict privacy guidelines [APIC Privacy Policy]

3. Privacy Principles

3.1 Data Collection

We collect information in alignment with APIC's privacy practices, including:

- - Professional contact information
- Membership details
- Event registration data
- Payment information (processed securely)

3.2 Data Usage

Information is used for:

- Chapter administration
- Professional communication
- - Event management
- Compliance with organizational objectives

4.2 Financial Transparency

- Chapter operates as a 501(c)(3) nonprofit organization
- Financial records are maintained in accordance with IRS regulations
