The APIC Chapter Legislative Role

The APIC website advises that the APIC public policy program monitors, analyzes, and guides legislative and regulatory proposals at the federal and state levels to protect patients and promote evidence-based policies.

In the Strategic Plan, 2020, APIC has established an advocacy goal for the organization to "Influence legislative and regulatory agenda for infection prevention with consumers, policy makers, health care leaders and workers across the continuum of care." APIC Sierra's Advocacy goal mirrors that of our parent organization.


Sierra Advocacy Goal - Promote awareness and understanding of HAI reportable measures and their role in infection prevention, by:

- functioning as a resource for members with regard to legislation and regulation, providing updates and information on mandated reporting requirements that affects our members
- Supporting the mission of the California APIC Coordinating Council (CACC).

The Chapter Board also appoints a Chapter Legislative Representative whose role is to act as APIC's representative to state and local policymakers on public policy matters, the CLR serves as the major link between his/her chapter, APIC HQ, and the APIC Public Policy Committee.

CDPH Updated Guidance on PPE for Ebola



Interim Guidance on Personal Protective Equipment (PPPE) To Be Used By Healthcare Workers in the Inpatient Hospital Setting During Management of Patients with Suspected or Confirmed Ebola Virus Disease (EVD) in California January 12, 2015

On January 12, 2015, CDPH issued an update to their guidance on PPE for Ebola Virus Disease.

From the CDPH website: CDPH is issuing a revision of the Interim "Guidance on Personal Protective Equipment (PPE) to be Used by Healthcare Workers in the Inpatient Hospital Setting During Management of Patients with Suspected or Confirmed Ebola Virus Disease in California". This revision outlines the recommended PPE for a suspected or confirmed Ebola patient based on clinical status, i.e. without and with symptoms of bleeding, vomiting, diarrhea, or a clinical condition that would warrant invasive or aerosolgenerating procedures. In addition, this guidance removes the CDPH specific recommendation for the use of airborne infection isolation for all Ebola patients at all times and recommends it only during the conduct of aerosolgenerating procedures.
