Public Lands Alliance 2026 Convention and Trade Show

Exhibitor Certificates of Insurance Due Friday, January 23, 2026

As stated in the [PLA 2026 Trade Show Contract \(item #10\)](#), it is necessary for all exhibitors to provide proof of general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 in all. If you do not have this coverage in place, we have made arrangements with PLA's insurance partner, Maury, Donnelly & Parr (MDP) , for you to acquire this coverage at significant savings through Total Event.

PLA requires written evidence in the form of a Certificate of Insurance for this additional coverage no later than January 23, 2026. If written evidence of additional insured coverage is not provided you will not be able to participate in the show (no refunds will be issued). If exhibiting company has multiple booths only one certificate of insurance is required.

For description of operations on the COI, please include "Public Lands Alliance Convention and Trade Show, February 22-26, 2026 and name Public Lands Alliance as the certificate holder with address (see example below). Policy effective date must cover the dates of February 22-26, 2026.
