



- All exhibits must be contained within the contracted exhibit space. No items (furniture, etc.) may be placed in the aisles. All displays must be free-standing and self-supporting. No hazardous materials may be stored or placed in display in the booth. Absolutely no company identification may be placed outside your specific booth area (i.e., on posts, pillars, walls, tables, ceilings, etc.) No music, live or recorded, will be allowed at individual booths except as might be included in a video tape or through headphones. No helium or light gas filled balloons are allowed.
- Name badges—you will need to wear your name badge during the conference. Please ensure we have the list of names needed at least two weeks before the conference date.
