**FEDERAL LAW:** 4.79% of your dues are used for lobbying and nondeductible as a business expense.

All dues and subscriptions are nonrefundable.

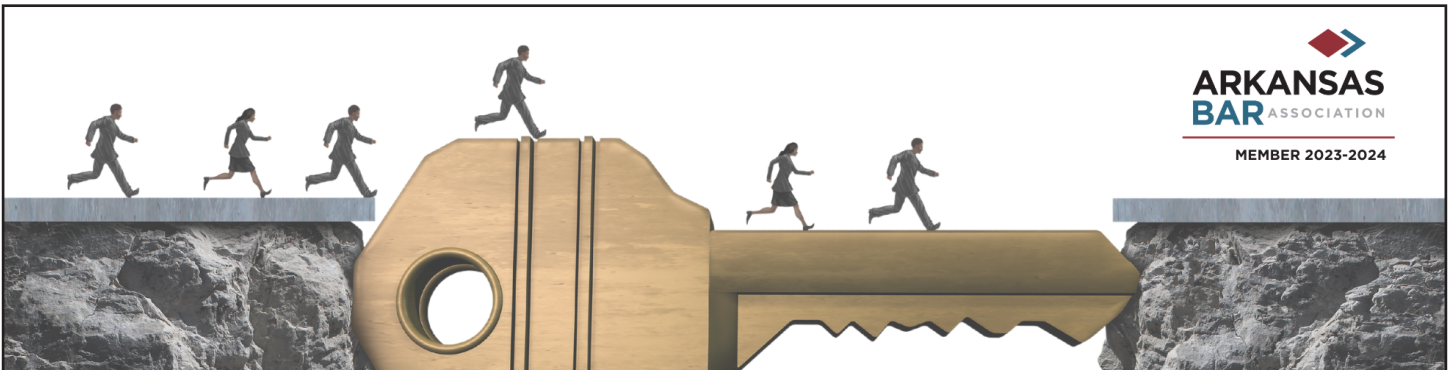
