## What is an ICF/DD?

Intermediate Care Facilities for people with Developmental Disabilities (ICF/DD) provide similar services as nursing homes, but have additional services and supports for people with developmental disabilities. Individuals who chose to live in an ICF/DD often have complex medical and/or behavioral needs. ICF/DD fill an important niche within the spectrum of services for people with disabilities in Minnesota.

## Licensed by DHS and MDH

Providers of ICF/DD must be licensed by the Department of Human Services and the Department of Health, meeting rules and regulations for both entities.

## Why are ICF/DDs needed?

- People with intensive medical or high behavioral needs require intensive services including 24-hour support, nursing care, pharmacy oversight, dietary support
- Many individuals have lived in their ICF/DD home for decades with the same housemates. Uprooting them would be very traumatic and disruptive.
- ICF/DD homes provide individuals and families with a choice of what setting is best suited for them.
- Higher needs individuals require a higher staffing ratio to support the individuals being served. ICF/DD homes have this.
- ICF/DD homes have higher internal controls relative to vulnerable adults and medically fragile individuals.

## Adjust ICF/DD rates

ICF/DD rates are determined outside of the Disability Waiver Rate System with the last rate increase for ICF services being in 2015 for 1%. With the recent investments made in waiver rates, a growing pay gap for Direct Support Professionals in ICFs versus waiver services is occurring.

ARRM's proposal would adjust ICF rates by 5%.

## Meet people's changing needs by allowing for variable rates

A variable rate is a tool that providers can use when an individual's needs change, due to aging or other health changes. It is the tool to request a higher reimbursement rate.

Current law restricts variable rate usage.

ARRM's proposal would remove the restriction on providers, allowing any provider to request a variable rate taking into consideration aging and changing needs as a reason to request a variable rate. It would create a process to request a variable rate similar to what is available to individuals that are served through a waiver.

## Address shortfalls in "Services During the Day"

As individuals grow older and retire from their day program more and more are utilizing the "Services During the Day" service, a custom service designed for community involvement during the day.

Currently, providers delivering this service, only get reimbursed at 75% of what the day program provider would be reimbursed to provide services to the same individual.

ARRM's proposal would change the reimbursement for "Services During the Day" to 100% of the DT&H reimbursement rate.
