The ASBMT Pharmacy SIG is seeking enthusiastic and motivated pharmacists working in the area of Hematopoietic Stem Cell Transplantation (HCT) to participate on the ASBMT Pharmacy SIG Steering Committee. At this time we are recruiting for four (4) qualified candidates to replace the members whose terms will end on February 26, 2018. Steering Committee members serve a two-year term with the option to serve longer if elected to serve as Chair. We will be recruiting for our six working committees in the near future.

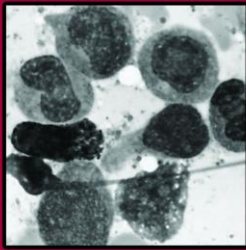
The ASBMT Pharmacy SIG Steering Committee member selection process is as follows:

A. *Candidates.* Any pharmacist who is a member of the ASBMT Pharmacy SIG is eligible to serve on the Steering Committee. Interested candidates must complete and submit an ASBMT Pharmacy SIG Committee Nomination Form and attach a recent copy of their curriculum vitae (CV).

B. *Re-Appointments.* Current Steering Committee members interested in re-appointment must also notify the Committee by the end of September of each year. An existing member may serve a second consecutive term only in the event that no other qualified individuals apply.

C. *Nominating Committee.* Candidates for the Steering Committee will be nominated by the current voting members of the Steering Committee. The Steering Committee will review the completed Steering Committee Nomination Forms and CVs of interested candidates during October of each year and will vote to select nominees. Nominees for Steering Committee membership must provide full disclosure of potential conflicts of interest prior to appointment to the Committee.

D. *Nominations.* The Steering Committee Chair will notify the Executive Director to the ASBMT President of the selected nominees to the ASBMT Pharmacy SIG Steering Committee by the end of November each year. Members of the Pharmacy SIG Steering Committee are officially appointed by the ASBMT Board of Directors.

4. Actively engaging ASBMT Pharmacy SIG members by communicating SIG initiatives and updating members on Steering Committee and Working Committee activities.

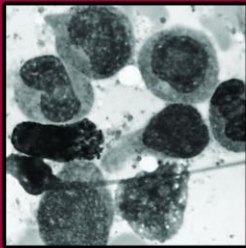

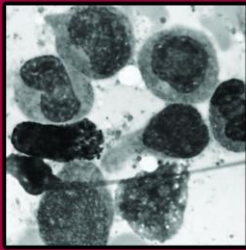

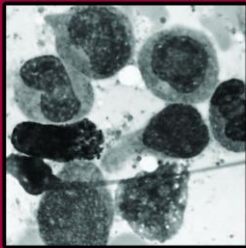
