# MEDICARE PHYSICIAN PAYMENT POLICIES IN FLUX

In early March, Congress released proposed text for the *Consolidated Appropriations Act, 2024*. Among the policies contained in the **1,050-page bill** is a partial fix for Medicare physician payments, which were cut by **3.4% in 2024**. The bill proposes a **1.68% payment bump**, which is still not enough to cover finalized cuts.

On the ASC payment front, Medicare has announced an upcoming demonstration project that will require physicians in 10 states to seek prior authorization before performing certain cosmetic surgery procedures often used to treat other conditions. ASCA anticipates the full program to be outlined in the 2025 proposed payment rule released this summer. David Weinstein, MD, specializes in sports medicine, knee surgery and shoulder and elbow disorders at the Surgical Center of the

Rockies in Colorado Springs. He is also a clinical associate professor at the University of Colorado, a US Olympic team physician and an ASCA Board member.

Dr. Weinstein discussed total shoulder surgery with CMS staff just before CMS agreed to add that procedure to the ASC Covered Procedures List.



As part of ASCA's recent National Advocacy Day, he also visited 10 congressional offices to advocate for policies that would improve patient access to care in ASCs.

"I fully believe that, whenever possible, one of the best things I can do for my patients is give them access to the exemplary care our ASC provides," Weinstein says.
