



Challenging

Thinking of the 2019 growing season and “challenging” is the only word I can think of to describe this year so far. Challenges occur each and every year, this year however, they seemed to compound. The year began with tight crop budgets for both our client and tenant farmers. Spring brought flooding and poor planting conditions. Unfortunately, some flooding is still occurring, and many acres did not get planted. Now the typical production problems are starting to show themselves, such as insect and disease pressure.

While dealing with these challenges, I have been looking for opportunities. Is there an opportunity to complete some needed property improvement on the prevented plant acres? Are there alternative crops that can improve crop budgets? Are there conservation options to take some marginal acres out of production to reduce some production risk?

While these challenges are widespread and many, if not all, of our membership is dealing with some of these issues, it is easy to feel alone in facing these challenges. I would like to take this opportunity to remind you that you are not the only one facing these challenges and encourage people to reach out to other members for advice or just to have someone listen to your concerns. Some of our seasoned members have been through challenges before and would be happy to discuss the lessons learned from their experiences. Other resources are available also.
