Federal Government (CMS)

- Skilled nursing facilities are closed to visitors (except for end of life situations), and all
 congregate services such as group dining and activities have been suspended; virtual visits via
 technology are encouraged; the 3 day hospital stay for Medicare beneficiaries prior to nursing
 home admission has been suspended
- CMS relaxes requirements for hospitals to offer long-term care services (through swing beds),
 Section 1135 waivers approved for more states: https://www.cms.gov/newsroom/press-releases/cms-news-alert-may-11-2020
- CMS requires weekly reporting of COVID cases in nursing homes that participate in Medicare and Medicaid no later than May 17: https://www.cms.gov/newsroom/press-releases/cms-news-alert-may-7-2020
- Collection of quality data for Medicare Nursing Home Compare has been suspended;
- Federal long-term care surveys for non-emergency issues have been suspended, but continue for infection control issues;
- Nursing home staff are required to have their temperature taken when they enter a facility, wear full personal protective equipment (PPE) including face masks, follow CDC guidelines on handwashing and comply with CDC guidelines on infection control;
- All staff and residents of skilled nursing facilities should be screened for symptoms of COVID 19;
- Residents with a COVID 19 diagnosis should be segregated from other residents, with dedicated staff providing their care;
- All positive COVID 19 diagnosis cases for residents must be reported to the CDC, as well as
 residents and their families within 12 hours of diagnosis, but there is wide variation in how this
 data is being reported.

CMS is allowing individuals who have completed an 8 hour temporary emergency nurse training
program to be employed as temporary nurse aides in nursing facilities to assist with staff
shortages (subject to approval by states) The American Health Care Association (AHCA) is
offering a free 8 hour class temporary nurse aide training class to any person that wants to serve

State Government

- Most states have taken similar measures to CMS skilled nursing facilities for assisted living
 communities, requiring closure to visitors except end of life situations, suspension of all
 congregate dining and activities, staff are required to have their temperature taken, wear PPE
 and follow universal infection control policies per CDC guidelines. Residents in independent
 living and ALFs are strongly encouraged not to make trips to the outside community unless
 medically necessary; virtual visits by family and friends are encouraged;
- Some states have created dedicated COVID 19 nursing home units, and there is an active
 discussion on where COVID 19 patients discharged from hospitals will go (home or to a nursing
 home);
- Reporting of COVID 19 cases varies throughout the US; some report at the county level while
 others report at the facility level. 14 states (AK, HI, NH, RI, IN, ID, KS, MO, MT, NE, SD, VT, WA,
 WY) are not reporting COVID 19 outbreaks publically, only reporting to the CDC. The list of

- Many states are asking their Governors to require COVID 19 testing for all staff and residents in nursing homes; NY and MD require COVID testing for all staff and residents.
- States have revisited their policies for allocation of resources such as ventilators during the
 COVID 19 crisis. Most states have a policy for allocation of resources, NPR provided an overview

- State Medical Reserve Corps have been activated and are busy credentialing all types of health
 workers (including retired clinicians) to serve as a backup health care workforce for hospitals
 and other health care organizations. Some states (Maryland) have a partnership with the state
 Department of Aging to have volunteers provide home care services to older adults living in the
 community who need care.
