Membership Levels

CCIM Designee/Candidate: To qualify you must be a current member of the CCIM Institute. This is an individual membership.

Broker: Current licensed broker. This is an individual membership.

Affiliate: Lenders, accountants, attorneys, insurance, etc. also, not a licensed broker. This is an individual membership.

Student: Must be currently enrolled in a Commercial Real Estate program and provide record of that to qualify. This is an individual membership. Student members may also attend luncheons at a reduced rate of \$20.

Agency: This membership is for agencies and allows two people (can change monthly) to attend the luncheon. The cost of the luncheon for 11 months is included in the membership fee.
