### Statement of Qualifications and Intention

#### **Qualifications:**

**Statement:** I earned my CFA charter in 1994 and am a member in good standing (see attached Membership Verification Letter). I have served on the CFA Society Philadelphia Board from 2014 to present, including roles as President (2018-2019). It is my intention to run for PCR.

#### **Vision for PCR Term**

My interest in the Presidents Council Representatives (PCR) stems from my desire to build on my experience with the CFA Society Philadelphia (CFAP) Board, experiences working with the CFA Institute as President of the CFAP and interactions with fellow Society Leaders at CFA Institute events (SLC Hong Kong 2018, London 2019, Americas SLC Vancouver 2018 and 70th CFA Institute Annual Conference Philadelphia 2017). Three areas I will focus on during a term as PCR would be:

1. **Grow the CFA charter and membership** by encouraging young finance professionals to seek the CFA Charter. It is critically important to broaden the candidate pool by encouraging prospective charter holders from a wide range of demographics. I strongly believe financial literacy efforts can lead a broader group of individuals to considering finance as a career.



- 2. Foster the critical relationship between the CFA Institute and the CFA Societies of the Eastern US Region. The unique dynamic between the Institute and Societies can be facilitated by effective communication.
- 3. The Eastern US Region is a critical component of the CFA with over 25,000 members represented. I look forward to building on the excellent work of the current Eastern Region PCR, Greg Filbeck. He has established a Society Leaders Conference for the Eastern Region, and I fully intend to continue that event. Focusing on regular communication and sharing best practices among the wide variety of Societies in the Eastern Region are important goals.
