- Evaluate and support the financial analysis of the existing and new business requirements, including the assessment of ROI.
- Conduct financial evaluations and analyses of USF (Universal Service Fund) lots in collaboration with stakeholders.
- Provide support in conducting pre-post investment financial analysis of COW (Cell on Wheels) sites based on the requirements in coordination with stakeholders.
- Perform post investment project financial evaluations for all delivered projects in compliance with existing policies and processes.
- Continuously optimize the ROI evaluation process by researching and implementing innovative evaluation methodologies.
- Monitoring and maintaining a centralized database containing the pre-post financial evaluation results of all evaluated projects.
- Support the Line Manager in the efficient execution and timely delivery of tasks assigned by the management.
- Proactively carry out compliance risk identification and evaluation, timely report compliance risks, and take actions to prevention and control compliance risk.
- Ensure strict compliance of existing policies and processes and support the internal and external audit activities and management.
- Act as a liaison among for effective inter- and intra-departmental coordination proactively, ensuring timely documentation and efficient management of trackers and databases.
