Founder and CEO

Mr. Faber is the founder and CEO of Cambria Investment Management. Faber is the manager of Cambria's ETFs and separate accounts. Mr. Faber hosts *The Meb Faber Show* podcast and has authored numerous white papers and leather-bound books.
