#### **Eligibility Requirements**

To enroll in the CFA Program and register for the Level I CFA exam, you must have an international travel passport and meet one of the following eligibility requirements:

- Current University Student
   Be within 23 months of completing your undergraduate degree
- Bachelor's Degree
   Completed a bachelor's program or equivalent program & received a university/college degree
  - Professional Work Experience
    Have a combination of 4,000 hours of work experience and/or college/university education that was acquired over a minimum of three sequential years and achieved by the date of enrolling for the Level I exam. Dates of education and professional work experience cannot overlap.
