The CFA Society San Diego was founded in 1962 as the Financial Analysts Society of San Diego, Inc. to promote a high standard of ethics and sound professional standards of investment management and research, and to enhance professional knowledge and skills. The Society was admitted to the Association for Investment Management and Research (AIMR) on November 4, 1963. In May 2004, AIMR became CFA Institute and in May 2005, the Society changed its name to CFA Society San Diego, in order to more closely align with the CFA Institute and the Chartered Financial Analyst (CFA®) designation.

There are over 600 members of the CFA Society San Diego, including security analysts, portfolio managers, bankers, and other investment professionals. Approximately 570 CFA Society San Diego members hold the Chartered Financial Analyst designation. In addition, approximately 305 are currently candidates for this prestigious professional designation.
