


# CFA® CHARTER: THE GOLD STANDARD



# CODE OF ETHICS

Adhere to this code of ethics.





# LEVEL I CFA® PROGRAM EXAM STRUCTURE

#### **Structure & Duration**

The Level I exam consists of 180 multiple choice questions, split between two 135-minute sessions (session times are approximate). There is an optional break between sessions.

First session (2 hours, 15 minutes): 90 multiple choice questions, covering the topics of ethics & professional standards, quantitative methods, economics, and financial statement analysis

Second session (2 hours, 15 minutes): 90 multiple choice questions, covering the topics of corporate issuers, equity, fixed income, derivatives, alternative investments and portfolio management

#### How to Study for the CFA Level I Exam

The best way to study for the CFA Level I Exam is to follow the CFA program curriculum and give yourself enough time to learn the material in your ideal learning style. Here are some resources candidates have listed as being most helpful for their exam preparation:

# LEVEL II CFA® PROGRAM EXAM STRUCTURE

#### **Structure & Duration**

The CFA Level II exam consists of 22 item sets comprised of vignettes with 88 accompanying multiple- choice questions.

The Level II exam is standardized with 11 item sets for each session, for a total of 22 on the exam. Twenty are scored, and two are questions we are trialing that will not be scored.

Multiple-choice questions in each item set must be answered based on the information in the vignette.

The Level II exam will be 4 hours and 24 minutes, split into two equal sessions of 2 hours and 12 minutes, with an optional break in-between.

#### How to Study for the CFA Level II Exam

- Make sure you know how to use the calculator features needed to address the learning outcome statements (LOS).
- Answer all questions. There is no penalty for incorrect answers.
- Take a CFA Level II mock exam to practice answering exam questions. This experience is designed to mimic the actual exam-day.
- Learn how hardware/software at the test centers may impact your exam-day experience.
- CFA Society Istanbul Hybrid Prep Courses (10 days, 5 weekends, like a review course, between March-April and September-October, twice a year)



# LEVEL III CFA® PROGRAM EXAM STRUCTURE

#### **Structure & Duration**

The Level III exam consists of item sets and constructed response (essay) sets. Both of these question types are comprised of vignettes with accompanying multiple-choice items for item sets and constructed response items for essay sets. All questions must be answered based on the information in the vignette.

Each session will have either 6 item sets and 5 essay sets or 5 item sets and 6 essay sets. This mixed distribution of item types across the two exam sessions creates a more-balanced delivery of questions throughout the exam. Overall, the Level III exam contains 11 item sets and 11 essay sets for 12 points each.

The Level III exam will be 4 hours and 24 minutes, split into two equal sessions of 2 hours and 12 minutes, with an optional break in-between.

#### How to Study for the CFA Level III Exam

- MMake sure you know how to use the calculator features
- needed to address the learning outcome statements (LOS).
- Answer all questions. There is no penalty for incorrect answers.
- Take a mock exam in the Learning EcoSystem to practice answering exam questions.
- Familiarize yourself with the software features of the exam in this software tutorial. Learn how hardware/software at the test centers may impact your exam-day experience.
- Dress comfortably.





#### What It Is

The CFA Institute Research Challenge is an annual global competition that provides university students with hands-on mentoring and intensive training in financial analysis and professional ethics. Each student will be tested on their analytical, valuation, report writing, and presentation skills. They gain real-world experience as they assume the role of a research analyst.

#### How It Works

Local level competitions are organized and judged by CFA Institute society members and volunteers who function as local hosts.

The winning university team from each local competition advances to the sub-regional competition.

The CFA Quant Awards is a prestigious international competition where university students and interns present original research in quantitative finance — from mathematical modelling and econometric analysis to machine learning applications. The latest edition is organized with the participation of CFA Societies in İstanbul, Belgium, France, Ireland, Italy, the Netherlands, and Spain. Over 50 papers were submitted, with the top 3 winning a prize and presenting their work at the Award Ceremony.

#### What is quantitative finance?

Quantitative finance applies mathematical and statistical models, as well as large datasets, to analyze financial markets and securities. Topics often include portfolio optimization, risk modelling, algorithmic trading, and applications of AI/ML in finance.


#### **ELIGIBILITY**
