HELD IN TRUST ADVISORY COUNCIL

The *Held in Trust* Advisory Council was comprised of organizations, many of which are already allied with the conservation field, who provided perspective and commentary on project goals and initiatives.

Advisory Council members whose areas of expertise are outside the field were also sought, with the intention of developing meaningful collaborations in areas such as racial justice, and environmental resource preservation. Members of the Advisory Council also disseminated project outcomes, such as the <u>Held in Trust Report</u>, to their memberships and audiences.

Advisory Council Biographies

Governor Brian Vallo

Brian Vallo, four-year director of the Indian Arts Research Center (IARC) at the School for Advanced Research resigned on Friday January 4, 2019. Starting immediately, Vallo will assume the role of Acoma Pueblo's governor. Upon his resignation, Vallo shared, "I am humbled by this great honor to serve my community as Governor, the responsibility is tremendous and the opportunities equally great. I have enjoyed working with such an amazing and competent staff to enhance signature programming and expand IARC's capacity to make an even greater impact to programs and new initiatives. This work has, and will continue to set new standards for collaboration, education, community engagement, and collections stewardship. SAR must take great pride in the positive impact of its initiatives to further advance the field of museology and capacity-building among tribal communities. I have every confidence the IARC and SAR will continue to lead important and impactful initiatives."

As the director of the IARC at SAR (School for Advanced Research), Vallo led a significant and nationally-recognized initiative on proper stewardship of Native American collections by spearheading the development and 2016 publication of a protocol for how source communities and collecting institutions can work together, known as the <u>Guidelines for Collaboration</u>. Vallo advised museum curators and exhibition-design teams on the implementation of the Guidelines, including recent work with the Metropolitan Museum of Art in New York and the Field Museum in Chicago. Under his guidance, the IARC collections grew to over 12,000 works of primarily Southwestern Native American art that span the sixth century to the present and SAR's Native American artist fellowship program continued to thrive. In his new role as the Governor of Acoma Pueblo, Vallo will continue to be influential in the emerging dialogue concerning source communities and collecting institutions.

Jontyle Robinson

Dr. Jontyle Robinson, trailblazing, innovative art historian/curator received her doctoral degree in art history from the University of Maryland, College Park and was the first curator for both the Spelman College Museum of Fine Art in Atlanta and Tuskegee University's Legacy Museum /Tuskegee Institute National Historic Site. Her groundbreaking research on Archibald Motley at the Chicago History Center resulted in New York City's Kenkeleba Gallery "Three Masters: Archibald Motley, Eldzier Cortor, and Hughie Lee Smith." In 1991, the Chicago History Center, mounted "The Art of Archibald John Motley, Jr" from her decade-long research which was, also, the foundation for the Whitney Museum's exhibition "Archibald Motley: Jazz Age Modernist"

on view from October 2015-January 2016. She curated/ co-authored for the Spelman College Museum of Fine Art's contribution to the 1996 Olympics, "Bearing Witness: Contemporary Works by African American Women Artists," the first exhibition /catalogue of contemporary African American women artists touring America. "Forever Free: Art by African American Women1862-1980" was the first. In 2016, Robinson conceptualized the Alliance of HBCU Museums & Galleries, a coalition of 11 Historically Black College and University Museums and Galleries. She is Founding Director.

There are Alliance students/programs at Yale University, Princeton University (two programs Princeton University Library and the Princeton University Art Museum), University of Delaware/Winterthur Museum; American Art Museum, Smithsonian Institution/Lunder Conservation Center, The Brooklyn Museum, the Cleveland Museum of Art, Crystal Bridges, UCLA/Getty, Georgia O'Keefe Museum, SUNY/Buffalo, American Institute for Conservation, the Bard Research Center in Manhattan, Harvard University Art Museums.

On August 30, 2020 Robinson was <u>featured in a segment</u> regarding students from HBCUs and art conservation on "CBS Sunday Morning."

The International Review of African American Art (Vol 30 No 1) published her article August, 2020 "Diversity in Art Conservation: Diverting the Crisis."

Julie Hart

As Senior Director for Museum Standards and Excellence at the American Alliance of Museums, Ms. Hart provides leadership and oversight of its Continuum of Excellence, a pathway of standards-based programs including AAM's Accreditation and Museum Assessment Programs, as well as AAM and field-wide standards and ethics initiatives. She has been involved with accreditation and efforts to nurture institutional excellence throughout her 25 year tenure at AAM, providing her with insight into the best practices, issues, and challenges faced by museums and non-profits of many types and sizes.

Ms. Hart is an internationally sought expert to speak and advise on the US model of museum standards and accreditation. She has developed and delivered numerous presentations, trainings, and multi-day workshops on accreditation and museum standards at national, regional, state, and international venues—including Italy, Saudi Arabia, Brazil, and China. She also co-created AAM's two-day professional education seminar Secrets of Accreditation and a two-year collaborative standards assessment project with the Institute of Museum Leadership in Mexico; and served as a consultant for the Alberta Museums Association's accreditation program.

She participates in the broader field of non-profit standards and accreditation by serving and Peer Reviewer and Council member for the Maryland Nonprofits' Standards for Excellence Institute. She also regularly does grant reviews for IMLS and spent many years as a member of the U.S. Army Certification Team Report Review Panel.

Prior to joining AAM, she pursued her interest in American art and museum work through curatorial and collections management training at the National Gallery of Art and the Smithsonian National Portrait Gallery. She holds an M.A. in Art History from The George Washington University and a B.A. in Art History and International Affairs from the University of Mary Washington.

Trevor Jones

I work as Director and CEO of History Nebraska, the state's historical society. We do pretty much everything you can imagine related to the state's history. History Nebraska includes a network of historic sites, the state museum, state archives, an entire squad of archeologists, and four amazing conservators with an independent lab. I also serve as the State Historic Preservation Officer and spend a lot of time thinking about the role historic buildings have in building strong communities. I spent years working as a curator and exhibition designer, and I'm passionate about making the cool artifacts museum workers get to touch more accessible to audiences. I've written numerous articles about making museum collections useful. I was also the co-editor of Active Collections, winner of the National Council on Public History's award for the best public history book in 2020. The global pandemic has made it a rough time to be a museum leader, but reading my historical picture book Major: A Soldier Dog to kids has been a welcome reminder of why our work matters.

Sarah Weicksel

Dr. Sarah Jones Weicksel, a historian and material culture scholar, is the Director of Research and Publications at the <u>American Historical Association</u>, where she oversees the AHA's research initiatives and publications program. She is also a Research Associate at the Smithsonian's National Museum of American History, where she recently co-curated with Amanda Moniz, *Who Pays for Education?* Her research and museum work focuses on United States history, material culture, race, gender, and the politics of everyday life. The author of several peer-reviewed articles, she is currently at work on a book about the American Civil War era. The project focuses on how people used clothing both to wage a cultural and political war against one another and as a tool for living through this conflict. Dr. Weicksel earned a PhD in History from the University of Chicago, an MA in American Material Culture from the Winterthur Program at the University of Delaware, and a BA in History from Yale University.

Larry Sloan

Larry Sloan stepped into the role of CEO at the American Industrial Hygiene Association (AIHA) in October 2016. Prior to this, he served as CEO for seven years at SOCMA, a trade association representing the interests of the US specialty chemical industry. Larry started his non-profit career at the Adhesive and Sealant Council, a trade association representing adhesive and sealant manufacturers, and was promoted to his first CEO role there in January 2005. He led this group for five years.

Larry began his career as a chemical engineer at Air Products and later worked for Nalco Chemical Company in marketing, manufacturing, and sales capacities.

Larry earned a BS degree in chemical engineering from the University of Pennsylvania, and later graduated from Northwestern University's Kellogg Graduate School of Management where he earned his MBA.

In 2006, Larry received his Certified Association Executive (CAE) designation through the American Society of Association Executives (ASAE). Currently he serves in a leadership role on the ASAE Foundation's Research Committee. Prior volunteer leadership roles include serving as board member and chair (in 2012) of the National Association of Manufacturers' Council of Manufacturing Associations; a board member of the *Société de Chemie Industrielle*; an executive committee member of the Science History Institute's Joseph Priestly Society; and a board member of the Chemical Educational Foundation.

Katie Risseeuw

Katie Risseeuw is the Preservation Librarian at Northwestern University Libraries, a position she has held since 2010. She manages collections care and preventative preservation programs and is involved with audiovisual and digital preservation. She has a Master of Science in Information Studies with a Certificate of Advanced Study in Preservation Administration from the University of Texas at Austin and a BFA in Art History from the University of Kansas, where her studio focus was printmaking and photography. Past work experience includes: projects at UT's Alexander Architectural Archive and the Video Game Archive, internships at the National Museum of Women in the Arts and Yale University Library, and positions at Powell's Books and the Harry Ransom Center's Film Collection. She is active in preservation sections of the American Library Association and the College Book Art Association.

Patricia Walsh

As the Public Art & Civic Design Senior Program Manager, Patricia Walsh overseas five program areas under the Equity + Local Arts Engagement department including Arts and Community Development; Arts in Civic Design; Creative Placemaking; Cultural Districts, Trails and Tourism; and Public Art. Through her work she engages with and works to educate local arts agency leaders on how to utilize the arts to equitably address community needs and goals. Her work aims to support professional development, resource building and networking opportunities for arts administrators to utilize the arts to create accessible public spaces, enable inclusive and equitable community development, and ensure the arts are an active component in equitable economic growth and sustainability.

Patricia is a member of the Arts and Planning Interest Group Steering Committee for American Planning Association, co-chair for the Washington District Council on Placemaking for Urban Land Institute, an artist selection committee member for two projects with the City of Rockville, Maryland, and a jury member for the Jorge and Darlene Pérez Prize in Public Art & Civic Design.

She holds a Master of Science in Arts Administration from Boston University, a Bachelor of Arts in painting from State University of New York at Plattsburgh, and an Associates in Applied Science in Commercial Art from Dutchess Community College.

Michelle Magalong

Michelle Magalong is a Presidential Postdoctoral Fellow at the School of Architecture, Planning and Preservation at University of Maryland. She brings to this role her extensive professional and research experience in community development, historic preservation and public health in underserved communities.

Magalong's work has been dedicated to telling the stories of historically marginalized groups through public humanities and historic preservation. Her doctorate in Urban Planning at University of California, Los Angeles (UCLA) focused on the process and development of the National Park Service Asian American Pacific Islander Heritage Initiative and Theme Study, part of the Park Service's recent effort to identify, acknowledge and preserve more inclusive and diverse historic sites.

During Magalong's two-year appointment at UMD, she will expand upon her dissertation work to explore the importance and impact of the National Park Service Heritage Initiatives that include the American Latino Theme Study, LGBTQ Theme Study and special resources studies on women, the Civil Rights movement and African American Heritage Initiative. Her research—Telling All American Stories: A Movement of Diversity, Inclusion, and Relevancy in Historic Preservation—has the ultimate goals of increasing the number of nominations and listings on the National Register of Historic Places and as National Historic Landmarks and raising the degree of scholarship on these kinds of historic preservation efforts. Currently, less than 10 percent of national landmarks are associated with African Americans, Asian Americans, Latinos, Native Americans, Native Hawaiians, Pacific Islanders, women and LGBTQ individuals.

She received her BA in Ethnic Studies and Urban Studies and Planning at University of California, San Diego (UCSD), and MA in Urban Planning at University of California, Los Angeles (UCLA). Dr. Magalong serves as President of Asian and Pacific Islander Americans in Historic Preservation (APIAHiP), a national volunteer-run, nonprofit organization. Her research and professional experience focus on community engagement, historic preservation, and social justice. She has served in advisory roles in historic preservation and community development, notably for the National Park Service, California State Office of Historic Preservation, and City of Los Angeles Office of Historic Resources. She was also recognized in 2018 as one of the "40 Under 40: People Saving Places" by National Trust for Historic Preservation.

Kristina L. Durocher

Kristina L. Durocher is the director and curator of the Museum of Art of the University of New Hampshire where she creates opportunities to teach and interact with art as a primary source for academic and social engagement. During her twenty-plus years working in the museum field she has curated interdisciplinary and collaborative exhibitions that are innovative and impactful; demonstrating commitment to the diversity and sustainability of visual arts and culture. Her educational programming creates pathways for identity-building, civic engagement, and empowers self-directed learning for people of all ages.

Ms. Durocher advocates for institutional and field-wide excellence, reinvention, and individual professional growth in her positions as president of the Association of Academic Museum and Galleries and vice-president on the board of directors of the New England Museum Association. In 2019, she co-edited, For Love or Money: Confronting the State of Museum Salaries, contributing an essay on legislation to end salary inequality. Recognized as a leader in the museum field, she was named a fellow of the Getty Leadership Institute in 2017. She holds a M.A. in Art History from the University of Massachusetts, Amherst with a concentration in contemporary art. She received a dual B.F.A. in Art History and Painting from the Massachusetts College of Art and Design, Boston.

Brent Benjamin

Brent R. Benjamin came to the Saint Louis Art Museum in 1999 from the Museum of Fine Arts, Boston, where he had served for 12 years in curatorial and administrative roles, culminating in five years as deputy director for curatorial affairs. As the Barbara B. Taylor Director of the Saint Louis Art Museum, he led the initiative to expand the Museum and raise \$160 million in the largest capital campaign for a cultural institution in St. Louis.

He has overseen the purchase of numerous works of art for the Museum, including Bartolomeo Manfredi's "Apollo and Marsyas;" Henry Ossawa Tanner's "Gateway, Tangier;" and Edgar Degas's "The Milliners;" and Andy Goldsworthy's site-specific sculpture, Stone Sea. He also has secured major gifts such as George Caleb Bingham's Election Series, Jackson Pollock's "Number 3, 1950" and notable collections of Chinese bronzes and post-war German paintings and drawings. Most recently, he initiated a series of donations that included Carolyn Danforth's late husband's extraordinary collection of more than 300 objects made by American Indian tribes from the Northern and Southern Plains; a gift of more than 1,300 Japanese woodblock prints and related materials from Charles and Rosalyn Lowenhaupt; nearly 150 European paintings, sculptures, drawings and prints from the collection of Mark Weil and Phoebe Dent Weil; and the transformative bequest by C.C. Johnson Spink and Edith "Edie" Spink of 225 works of art, including important American paintings and more than 200 works of Asian art.

Brent Benjamin received his undergraduate degree from St. Olaf College and holds a graduate degree in the History of Art from Williams College, where he was named the Robert Sterling Clark Fellow. He attended the Qualifying Graduate Program in Architecture at Rice University and the Harvard University program for Art Museum Directors

Ellen Pearlstein

Ellen Pearlstein was the Senior Objects Conservator at the Brooklyn Museum in New York, where she also served as an advisor on NAGPRA. She was adjunct faculty and later chair of a curriculum review committee at the Institute of Fine Arts-Conservation Center at NYU. Ellen has designed and taught courses in Egypt and the Netherlands, supervised conservation interns from Egypt, Germany, France and the UK, and has lectured at graduate programs at the University of Delaware-Winterthur and Buffalo State College. In 2005, Ellen assumed a faculty position in the UCLA/Getty Program in the Conservation of Archaeological and Ethnographic Material. As a member of the founding faculty, Ellen and her colleagues designed curriculum, outfitted a laboratory, and Ellen began teaching graduate classes in the conservation of organic materials, ethics of working with indigenous communities, preventive conservation and managing collections. In 2008, Ellen joined UCLA's Department of Information Studies, and invited students interested in library and archive materials into her preservation and management classes. Ellen's research includes conservation of featherwork and basketry, effects of environmental agents; pre- and post-Hispanic geros from the Andes; and curriculum development within conservation education. Ellen is a Fellow in the American Institute for Conservation and the International Institute for Conservation. winner of the Keck award, and President of the Association of North American Gradate Programs in Conservation.

Gina Crevello

Gina Crevello is an architectural conservator and a professional associate (PA) of the American Institute of Conservation. She is principal of Echem Consultants LLC, a recognized forensic, corrosion and material science consultancy which she founded in 2009. With 23 years' experience, Gina has been working specifically in material diagnostics and durability engineering for more than a decade. Jennifer Jae Gutierrez is Executive Director of the <u>Image Permanence Institute</u> (IPI) at Rochester Institute of Technology (RIT). IPI is an academic research laboratory, within the College of Art and Design, focused on research that informs the preservation of cultural heritage collections. Areas of expertise include the preservation of photographic materials and sustainable practices in preservation environmental management.

Prior to her appointment at RIT, Jae was the Arthur J. Bell Senior Photograph Conservator at the Center for Creative Photography (CCP), University of Arizona, Tucson where she established the institution's conservation department. Before that, she held a faculty appointment in the Art Conservation Department at the University of Delaware (UD) where she taught undergraduate- and graduate-level courses in preventive conservation, conservation ethics, and the conservation of photographic materials. She also served as Associate Director of the Winterthur/University of Delaware Program in Art Conservation from 2010-2012.

Jae is a professional associate of the American Institute for Conservation (AIC) and has a Master of Science in Art Conservation from the University of Delaware specializing in photograph conservation. Recently published essays include *The Preservation of Platinum and Palladium Prints: Storage and Display* (American Institute for

Conservation, 2017), Preventing Destruction: Preserving Our Irreplaceable Photographic Heritage (Smithsonian, 2017), and Pinups, Photograms, Polaroids and Printing Plates: Iterations in Robert Heinecken's Work Process (Museum of Modern Art, 2014). With Debra Hess Norris, she edited Issues in the Conservation of Photographs published by the Getty Conservation Institute in 2010.

Elysia Poon

With two decades experience in the museum field, Elysia's career has demonstrated a commitment to collaborative programming and a dedication to community-based collections care. Under her leadership, the IARC continues to be at the forefront of the national conversation around how collecting institutions and Native American communities can work together to foster and promote cultural heritage and further contemporary art practices. Formerly the IARC's curator of education, Elysia furthered a Native artist fellowship program and developed an internship program that is now one of the most nationally recognized. She also developed and led IARC education outreach initiatives and programming. Sarah Gould

Sarah Zenaida Gould. Ph.D. is Interim Executive Director of the Mexican American Civil Rights Institute, a national project to collect and disseminate Mexican American civil rights history. A longtime public historian, she has curated over a dozen exhibits on history, art, and culture, and was formerly founding director of the Museo del Westside and lead curatorial researcher at the Institute of Texan Cultures. Gould is co-founder and co-chair of Latinos in Heritage Conservation, a national organization that promotes historic preservation within American Latino communities and advocates for the protection of Latino tangible and intangible heritage. Additionally, she serves on the board of the Friends of the Texas Historical Commission, on the council of the American Association of State and Local History, and is an active member of the Westside Preservation Alliance, a coalition dedicated to promoting and preserving the workingclass architecture of San Antonio's Westside. Tom Clareson is Senior Consultant for Digital & Preservation Services at LYRASIS, consulting internationally on preservation, disaster preparedness, digitization, funding, strategic planning, and advocacy for arts and cultural organizations. He also serves as

Project Director of Performing Arts Readiness, funded by the Andrew W. Mellon Foundation to help performing arts organizations protect their assets, sustain operations, and prepare for emergencies. Clareson is Vice President of the Board of Directors for the Foundation for Advancement in Conservation, Board of Directors Secretary of LancasterChorale (Ohio), and a member of the National Board of Advisors of the Richard M. Ross Art Museum at Ohio Wesleyan University. He has experience teaching graduate-level courses for the University of Texas at Austin, University of California-Los Angeles, and University of Illinois Urbana-Champaign.

Stephen Kidd

Stephen Kidd is the executive director of the National Humanities Alliance. Before joining NHA, he was director of the Smithsonian Folklife Festival, the Smithsonian Institution's "Museum without Walls." As director, he oversaw the development of major, research-based exhibitions including, among others, Crisis and Creativity: Unfolding the AIDS Memorial Quilt (2012), Colombia: the Nature of Culture (2011), and Asian Pacific Americans: Local Lives, Global Ties (2010). Rob Niewig

Today, as Vice President, Rob leads a group of experienced preservation professionals working from New York City, Chicago, Atlanta, Washington DC, Houston, Denver, and Los Angeles. The Preservation Services & Outreach Department provides grant funding, technical assistance, training, and educational materials. Each year we convene the preservation movement at PastForward, the national conference. The department also leads effective coalitions to save historic places, specializing in solutions-oriented advocacy in collaboration with public- and private-sector partners.

As an attorney, Rob enables public participation in preservation-based land-use planning, federal Section 106 consultation, and other administrative review processes. Rob holds degrees from Vassar College, Columbia University, and the University at Buffalo Law School.

Carrie Villar

Carrie Villar is the John and Neville Bryan Senior Director of Museum Collections at the National Trust for Historic Preservation. In this role, she manages the National Trust's museum collections, which includes historic buildings, landscapes and 60,000 objects. At the Trust she has also served as the Acting Vice President for Historic Sites, as well as the Interim Executive Director of the Woodrow Wilson House.

Ann Hitchcock is Senior Advisor for Scientific Collections and Environmental Safeguards, National Park Service. She was NPS Chief Curator 1980-2007.

Prior to joining NPS she served as Assistant Chief Curator, Manitoba Museum, Winnipeg, Canada (1977-1980) and Registrar of Anthropological Collections, Museum of Northern Arizona, Flagstaff (1970-1976).

Ann Coats Amati

Anne Amati is the NAGPRA Coordinator and Registrar at the University of Denver Museum of Anthropology (DUMA) in Denver, CO. DUMA is dedicated to increasing knowledge and understanding of world cultures and human diversity while emphasizing the ethical stewardship of collections, research, teaching, educational programming and responsible community engagement. DUMA acknowledges that colonial legacies are embedded in anthropological collections and it strives to address historical wrongs by building collaborative, reciprocal relationships and respecting the rights and cultural protocol of communities represented in the collection. Ms. Amati is responsible for compliance with the Native American Graves Protection and Repatriation Act (NAGPRA) as well as ensuring that the University is cultivating and maintaining good relationships with tribes.

Ms. Amati is the PI for a three-year initiative to develop a network for individuals engaged in implementing NAGPRA funded by an Institute of Museum and Library Services (IMLS) National Leadership Grant for Museums. The NAGPRA Community of Practice aims to create a network of NAGPRA practitioners across the U.S. to: increase capacity for implementation in museums; improve overall engagement of the museum field with ongoing NAGPRA work; and decrease misunderstanding and confusion still associated with NAGPRA among some museum professionals. While the project began with a focus on implementation in museums, the scope of the NAGPRA Community of Practice has since broadened to be for all NAGPRA practitioners. This is because we believe implementation in museums will only improve if NAGPRA practitioners from museums, tribes, federal and state agencies, and other disciplines, can come together on a regular basis to learn from each other. As a result, NAGPRA implementation should improve not only in museums, but across the NAGPRA community.

Curt DiCamillo

Curt DiCamillo is an American architectural historian and a recognized authority on the British country house. He has written, lectured, and taught in the U.S. and abroad on British history and architecture and leads scholarly tours that focus on the architectural and artistic heritage of Britain and its influence around the world. Since 1999 Curt has maintained an award-winning database on the web, The DiCamillo Database of British & Irish Country Houses, which seeks to document every English, Scottish, Welsh, and Irish country house ever built, standing or demolished, together with a history of the families who lived in the houses, the architects who designed them, and the history of the houses' collections and gardens.
