## **Data Center Concepts for the Real Estate Professional**

How many times have you tapped electronic data today? Our staggering appetite for data continues to drive the data center market, so we were glad to hear the latest insights from a panel of experts on November 29, 2017 at Digital Realty in Clifton.

2017 was a whirlwind year for me crisscrossing the country as a civil engineer for fast-track data center developments. On that Wednesday evening in Clifton, I had the pleasure of introducing industry experts and then sitting back to hear their understanding of the market today, and expectations for the future. Rick Drescher, Managing Director for the Critical Facilities Group at Savills Studley, moderated the panel consisting of:

- Steve Verp, Director of Real Estate for Digital Realty and our host for the evening;
- Andrew Graham, Director Critical Environments Group; and
- Justin Broadbent, Manager for the Infrastructure Services Group at SHI International Corp.

First we were given a high-level overview of the New York/New Jersey data center market, including opinions on market strength moving forward and where the demand is coming from.

Turning to client expectations, the panel discussed key data center marketability elements such as colocation, cloud, and connectivity; what end users desire of these elements in their leased data center space; and how these tangible items directly relate to managing a real estate portfolio. The panelists discussed site selection considerations—expanding from the New York Metro market to considerations in the greater Northeast geography; lease/licensing agreement structures; and requirements that we can expect to be included in future data center occupancy deals.


