### Fast Facts & Industry Stats

Economic Development in the Carolinas continues to be strong amid a nationally soft market. Both states have welcomed new business and industry, investing heavily into local communities and creating hundreds of jobs throughout the region. Here are just some of the companies that have recently relocated or expanded:

#### **NORTH CAROLINA**

**Mack Trucks** will be moving its headquarters to Greensboro as part of a corporate restructuring, further defining Triad as transportation industry hub. The move is expected to create 493 jobs and invest \$17.7 million in Guilford County during the next three years.

**GE-Hitachi Nuclear Energy** is expanding its New Hanover County nuclear operations headquarters. Nine hundred jobs new jobs are anticipated with this \$678 million capital investment.

**Titan America LLC,** a major cement manufacturer, is investing \$469 million into New Hanover County to create 161 new jobs.

**Reliance Industries USA, Inc.** will open its first North American manufacturing facility to produce a resin used in the production of plastic containers and specialty polyester yarns. This new \$215-million facility will bring 204 new jobs to the Kinston area.

Fountain Powerboats, Inc. is investing \$12 million to expand its Beaufort County manufacturing facilities, allowing the company to produce a new line of boats. Over 250 new jobs will be created.

**Stanley Furniture,** founded in 1924, is expanding to create 205 new jobs through a \$1.5 million investment in its Robbinsville location.

**Merck & Co., Inc.** is expanding its Durham vaccine manufacturing facilities with a significant \$300-million investment, creating 150 new biotech jobs.

#### **SOUTH CAROLINA**

Carolina AAC is locating a new manufacturing facility in Marian County where the company will produce Autoclaved Aerated Concrete (AAC) for commercial and residential use. The \$17-million capital investment will create up to 40 jobs, as well as become a catalyst for generating countless green industry construction jobs throughout the Southeast U.S., as its products are vital elements to LEED-certified projects.

**Ahlstrom,** a Finland-based company specializing in fiber-based materials, is expanding its non-woven textile facility. The \$16-million investment is expected to create 144 jobs in Kershaw County. Ahlstrom is a global leader in the development, manufacturing and marketing of high performance fiber-based materials used in a large variety of everyday products, such as filters, wipes, flooring, labels and tapes.

Kannapolis, NC welcomes The North Carolina Research Center (NCRC), a private-public venture created to foster collaboration and further advancements in the fields of biotechnology, nutrition and health. The first portion of this expansive campus, the David H. Murdock Research Institute (DHMRI), is scheduled to open in mid-2008. The visionary behind the NCRC is David H. Murdock, CEO of Dole Foods, whose \$1.5 billion investment opened the door to make the Kannapolis campus a reality.

According to the NCRC website, "The campus will offer more than a million square feet of state-of-the-art lab and office space, including the DHMRI, which houses one of the largest and most advanced scientific equipment collections of its kind anywhere in the world, including state-of-the-art technology in genomics, proteomics and metabolomics. Here, universities and private businesses will have the opportunity to test, explore and advance scientific knowledge across a variety of disciplines."

The NCRC campus will also include 160,000 square feet of medical office space, as well as experimental greenhouse facilities for use by tenant companies. Additionally, the ultimate project vision includes town homes and retail. Kannapolis and the surrounding communities are certain to experience significant positive impact from this biotech investment.

More than a flexible work program, My Work is a culture. And it's steadily growing, with 7300 eligible associates currently enrolled and plans for continued aggressive adoption.



## **LEED Project Surge** in the Carolinas

As a follow-up to last quarter's feature article on the benefits of commercial development "going green", it is exciting to note that the Carolinas are currently home to a significant number of LEED-Registered and LEED-Certified projects.

According to the U.S. Green Building Council, "The Leadership in Energy and Environmental Design (LEED) Green Building Rating System™ encourages and accelerates global adoption of sustainable green building and development practices. LEED is a third-party certification program and the nationally accepted benchmark for the design, construction and operation of high performance green buildings." To receive LEED certification, a building must meet rigorous criteria in five categories: sustainable site development, water conservation, energy efficiency, conservation of materials and resources, and indoor environment quality.





## Reaching Out, Making a Difference
