## **Membership Type Descriptions**

**End User** members are those individuals with real estate or real estate related responsibilities. They are focused on the workplace or infrastructure management for public, private or governmental organizations. This organization utilizes or leases real estate for its own needs, rather than for investment, sale, or development. Service Provider members are those individuals in professions that serve the needs of the corporate real estate executive. This includes, but is not limited to: property managers, brokers, builders and developers, consultants, architects, attorneys, etc. The primary focus of the service provider member is to attract business for economic gain, i.e. to manage accounts or provide some service.
