### Nomination Guidelines

Nomination submissions should address the award criteria, as detailed for each award on the following pages. Submissions will be judged against these criteria, and responses must specifically answer the nomination criteria for the submission to be considered complete. The narrative should provide specific examples of how the award criteria were met. We strongly encourage your submission to speak directly to the criteria, describe accomplishments and outcomes, and highlight measurable results.

To be eligible, nominations must include one CoreNet member in good standing at the time of the nomination.

- For **Corporate Executive, Young Leader, and Service Provider of the Year**, the nominee must be a CoreNet Member before July 1, 2025.
  - For the **Corporate Executive Team**, one of the team members must be a CoreNet Member before July 1, 2025. Individuals cannot be nominated for a role they are no longer currently in. Self-nominations are not allowed.
- For the **Innovative Workplace of the Year**, one person on the team must be a CoreNet Member (with active membership status before July 1st, 2025).
- Nominations may be submitted by anyone, including Non-CoreNet Members.
- There is no cost to submit a nomination.

The Chapter and CoreNet Global shall not be held responsible for the accuracy of any statements submitted on a nomination. All parties included in the nomination must have advanced awareness of and approval of the submission.

The deadline to submit a nomination is **Thursday, September 4th, 2025, at 5:00 pm PST**. **All fields on the form must be filled in. Any changes to the nomination form will not be accepted after submission.**

The judges for the REmmy awards have varied backgrounds in corporate real estate and are highly respected industry leaders who are committed members of CoreNet Global. These judges are affiliated with CoreNet Global chapters located outside of Southern California. Any discussions related to nomination submissions and selection processes will be kept confidential. Evaluation of submissions will be based on the criteria specified below.

### **CORPORATE REAL ESTATE EXECUTIVE OR TEAM OF THE YEAR**

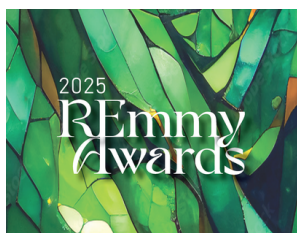
Recognizes the Corporate Real Estate (CRE) Executive and/or Team that made outstanding and distinguished contributions to their company and to the profession. This executive or team is dedicated to ensuring a safe, productive, and engaging workplace. This award category is limited to End Users.

## **AWARD CRITERIA**

The judges will use the following criteria to review submissions and select the winner. The percentages denote the weighting used for the scoring process.

35%	Demonstrates commitment to the field of corporate real estate, through CoreNet Global, Chapter, and other professional channels
35%	Demonstrates leadership of new methods, models, and practices to improve the vitality and success of the portfolio and workplace
30%	Makes significant contributions to achieving the company's objectives and success through portfolio strategies, workplace strategies, and organizational strategies, including diversity

#### **YOUNG LEADER OF THE YEAR**

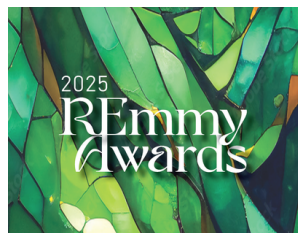
Recognizes the Young Leader who showed dedication and enthusiasm for his/her work and contributed to his/her profession or recognized by his/her employer for achieving substantial and lasting influence. This individual exemplifies excellence and should be considered 'one to watch' in the field of corporate real estate (CRE) in any member category. The nominee must be age 36 or younger as of December 2025.

#### **AWARD CRITERIA**

The judges will use the following criteria to review submissions and select the winner. The percentages denote the weighting used for the scoring process.

35%	Demonstrates commitment to the field of corporate real estate and the growth of his/her career, through active participation in professional forums such as CoreNet Global, Chapter, and other professional channels
25%	Demonstrates understanding of technical aspects of corporate real estate and shows growth and progression in career
25%	Made a direct impact to the success of the company and the positive impact of the workplace
15%	Recognized by his/her supervisor, peers, and/or company for excellence

#### **SERVICE PROVIDER OF THE YEAR**

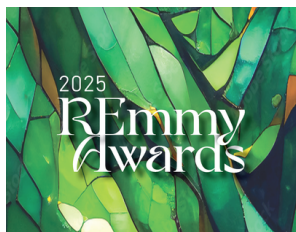
Recognizes an individual whose performance and client interactions provide a uniquely valued experience to those with whom they work and whose actions that transcend the expected.

#### **AWARD CRITERIA**

The judges will use the following criteria to review submissions and select the winner. The percentages denote the weighting used for the scoring process.

35%	Demonstrates ability to consistently provide and deliver professional services that go above and beyond client expectations; Puts client first
25%	Demonstrate commitment to the field of corporate real estate, through CoreNet Global, Chapter, and other professional channels
20%	Applies new solutions, methods and innovative practices to solving familiar and emerging challenges in CRE
20%	Makes significant contributions to achieving the company's objectives and success through portfolio strategies, workplace strategies, and organizational strategies

### INNOVATIVE WORKPLACE OF THE YEAR

Recognizes innovation in workplace design or construction based on the total square footage of the build-out:

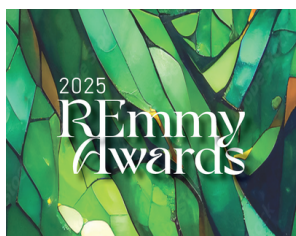
- Innovative Workplace - Less than 50,000 SF
- Innovative Workplace - Greater than 50,000 SF

### AWARD CRITERIA

The judges will use the following criteria to review submissions and select the winner. The percentages denote the weighting used for the scoring process.

30%	Implemented thoughtful and unique approaches to achieve, or exceed in achieving, the end user's (client's) objectives
20%	Produced quantifiable outcomes that demonstrate improvements or enhancements to the core business and/or workplace environment
20%	Demonstrates design excellence, creating a workplace environment that is inspirational, inclusive, and/or demonstrates WELL building standards and sustainable practices
10%	Acts as an example of team collaboration with best practices and methods
10%	Applied new and innovative and sustainable materials

### Frequently Asked Questions (FAQ)

#### General Information

##### What are the REmmy Awards?

The REmmy Awards celebrate excellence and innovation in corporate real estate. The awards recognize outstanding projects, teams, and individuals across various categories that demonstrate leadership, creativity, and impact.

##### Who can submit a nomination?

Nominations can be submitted by CoreNet Global members, project partners, or anyone involved in the nominated work. Self-nominations are not allowed.

##### Who is considered a Service Provider?

A service provider is a strategic partner that includes architects and interior designers, brokers, project managers, general contractors, developers, investors, landlords, owners, furniture manufacturer/dealer, and other vendors who make up parts of the CRE supply chain.

##### Do I need to be a CoreNet member to submit a nomination or be nominated?

CoreNet membership is *not required* if you are nominating someone else for a People Award. However, the person being nominated **must** have an **active CoreNet membership through December 31, 2025** for the nomination to be eligible.

##### Is there a fee to submit a nomination?

No, submitting a nomination is completely free.

##### Can you submit your nomination electronically?

Yes. All nominations are submitted electronically.

#### Submission Process

##### How do I submit a nomination?

Submissions must be completed through our online submission portal. A link to the form is available on the REmmy Awards webpage.

### Submission Process (Cont.)

#### What information is required for the submission?

Submissions typically include:

- Project or nominee overview
- Category selection
- Project scope, objectives, and outcomes
- Photos
- List of key contributors and partners

#### Can I submit more than one nomination?

Yes, multiple nominations are allowed as long as each one meets the eligibility requirements for its category.

### Deadlines & Timeline

#### What is the deadline to submit a nomination?

The deadline for 2025 REmmy Award nominations is **Thursday, September 4, 2025 at 5:00 PM PST.**

#### When will the 2025 nominees be announced?

Nominees will be notified in mid-September via email. Winners will be announced live at the REmmy Awards Gala on November 13, 2025.
