- Ensure nominations are supported by clear and concise evidence of the nominees' achievements and inputs provided by a diverse audience of peers to ensure all achievements are noted, if relevant to the submission. Remember the nominations will be reviewed by senior members of the corporate real estate profession and the quality of nomination should reflect this.
- Bio or CV and Photo need to be included with submission.
- Finalists will need to make themselves available for an interview.

## QUESTIONS TO BE ANSWERED / CRITERIA FOR SELECTION OF GLOBAL WINNER

1. Involved in innovative strategies and/or projects that changed the conversation with the C-Suite and other business leaders with the goal of aligning the objectives of the organization. Describe the solutions and how these were implemented as part of your organisation's CRE strategy. (35 points)
2. Demonstrated a diverse set of skills that helped the CRE function gain status as an equal partner in a collaborative role either with key support functions in the company, e.g., HR and IT and/or business groups within the enterprise (35 points)
3. Developed and implemented strategic initiatives and goals that have a companywide impact, such as fostering an inclusive workplace culture, advancing environmental sustainability, leveraging innovative technologies like generative AI, and adopting transformative practices in corporate real estate. Describe the implementation and the impact. (30 points)

**Maximum 400 words for all questions above**

4. Please describe an initiative or project you have led or been significantly involved in within the field of corporate real estate (CRE) that has delivered substantial value to your organization. How does this initiative set you apart from other submissions, and what were the key success factors that contributed to its success? (20 points)
