CRE EXECUTIVE OF THE YEAR

John Mathew

Executive Director, Global Real Estate & Master Planning, Charles River Laboratories


PROJECT OF THE YEAR AWARD


Audible, Newark NJ


In 2019, Audible relocated its corporate headquarters to Newark, NJ. The project sought to provide employees with a sustainable, healthy campus while maintaining the Newark community's cultural and historical identity. Tasked with renovating 71,352 sf of commercial office space at One Washington, HLW's goal was to combine technology and sustainability with diverse space types to encourage users to interact with their space in various ways.

Audible and HLW worked together to establish a framework for providing this variety across each scale of the project: all-hands areas to engage the entire community, gathering spaces to connect business units and groups, huddle spaces for smaller groups or one-on-ones, and focus areas for solo work.

Audible's primary new workspace objectives were sustainability and wellness. Dedicated to pursuing the LEED Gold level, the project prioritized strategies to achieve credits in the Indoor Environmental Quality, Energy & Atmosphere, and Indoor Water Use categories.









PROJECT OF THE YEAR AWARD continued

Member Spotlight:

Sustainable strategies utilized as follows:

- Selected a central, accessible, and walkable location in Newark to reduce the need for personal car use in commuting.
- Repurposed over 75% of office furniture from Audible's previous space to reduce project waste and supply chain-derived emissions.
- Prioritized products with material health transparency and optimization documentation - EPDs (Environmental Product Declarations) and low VOC emissions to promote healthy and sustainable materials.
- Installed CO2 sensors, MERV 13 filtration, and exhaust for restrooms and janitors' closets to ensure high air quality.
- Designed for daylight and quality views.

With a solid commitment to their people and local environment, Audible's One Washington Headquarters attained three rating systems: LEED v4 ID+C Gold, WELL Health-Safety Rating, and Fitwel 2 Stars.

Audible's space achieved:

- A 35% reduction in water use from the LEED baseline.
- A lighting power density reduction of 25% from ASHRAE.
- A 25% reduction in GWP (CO2e/sf) compared to the baseline following a LCA.
- 55% SDA (spatial daylight autonomy), following a daylight analysis.

The event also acknowledged the students from Project Destined x Rutgers University Real Estate Academy. The Chapter sponsored
















Member Voices:
