A Conversation with Jennifer Starbuck, Senior Vice President, Global Head of Real Estate, Chubb

One of the key benefits of CoreNet Global membership is the opportunity to learn from peers. Newsletter editor Paul Garvey recently sat down with Board Member and volunteer, Jennifer Starbuck, and asked her to share her thoughts on her career and the industry. Jennifer has had a tremendous and varied career in commercial real estate, starting as a property manager with Jackson-Cross and Trammell Crow Company. She is now Senior Vice President, Global Head of Real Estate for Chubb. In her 30-year career she has

worked on the investor side and the occupier side of the house. She has worked for owners, corporates and service providers and has gained a wealth of experiences along the way. Please enjoy.

Q: How did you select commercial real estate as a career?

A: My mother, step-father, one sister, an aunt and several cousins are all residential real estate brokers. My father, an uncle and my grandmother were all commercial brokers. Real estate was the favorite topic at the dinner table when I was growing up. I was always fascinated by the complexity and nuance and with watching them work deals. I took my first job as an assistant property manager at a large office and industrial complex, right out of college and haven't looked back. I love the bricks and mortar, but I love even more how real estate serves the people it houses.

Q: What advice do you have for professionals new to the business? Any special advice for women?

A: Don't chase the money. Easy to say, right, with student loan debts hanging over your head? But too many people come into the field focused just on the earnings potential and not on the fit and passion. Commercial real estate offers a vast array of paths and opportunities suited for all types of people and interests. Early years in your career should be about exploring and exposing yourself to as many of those areas as possible. There are opportunities to be analytical, creative, persuasive, pedantic. Real estate isn't as much an industry as it is a practice – it overlaps finance, technology, human resources, manufacturing, government,

CoreNet Philly Gives Back

The CoreNet Global Philadelphia Chapter's Community Reinvestment Committee organized an event on January 24th at the Philabundance Hunger Relief Center in South Philadelphia. This year was the chapter's fifth annual event supporting Philabundance, the region's largest hunger relief organization.

Philabundance provides food to 90,000 individuals each week via neighborhood distribution programs and 350-member agencies including food pantries, shelters, and emergency kitchens in the Delaware Valley. One in five people in the Philadelphia area face hunger.

Twelve volunteers sponsored by CoreNet spent 3.5 hours packaging 598 boxes of assorted food and beverage items for delivery to senior citizens in the Philadelphia region. The boxes weighed 28.3 lbs. each for a total of 16,923.4 lbs. of food products. The Community Reinvestment Committee will organize another event at Philabundance later in 2019 or early next year.

public works and dozens of other industries. Careers Building Communities is a great place to start if you want to understand the paths open to you. And if you are narrowing your focus to corporate real estate, the QPCR designation offered by CoreNet Global is designed just for you.

For young women and minorities entering the field, you'll find that diversity is embraced in some segments like corporate real estate, but generally lags other industries. The social barriers have started to melt, thanks in part to the changes in technology and how that supports a more even playing field. But there are still areas of the business where women and minorities are under-represented – transactions, capital markets, development. The good news is that most big players in real estate are making serious investments in improving diversity and inclusion.

Q: After you started in the industry, you took time to get your MBA from Wharton, as well as your MCR Certificate from CoreNet. Why, one or the other, value of both?

A: I've always said if I won the lottery tomorrow, I'd be a fulltime student for the rest of my life. So going back to school was always in the plan. Following a successful career in investor real estate, I found that I was becoming less interested in the financial asset and more interested in how real estate fulfilled an important role in organizations. I am fascinated by how environment impacts the employee experience and productivity. I wanted to understand how a corporate real estate organization could provide value to corporates. The Wharton MBA for Executives program was therefore both an indulgence and an important tool in pivoting my career into an area of real estate completely new to me. After landing my first role in corporate real estate as an outsourced director of US facilities for TD Bank, I was introduced to CoreNet by colleagues. The MCR seemed like a good way to refine my skills and deepen my understanding of the role corporate real estate plans in corporates. I learned everything I expected to and more from the program - with

the added bonus of developing a great extended network of colleagues in the business, many of whom were MCR classmates along the way.

Q: After spending the first part of your career working on the owner/ investor side, you switched to working as a service provider for occupiers. What did you learn from working with occupiers that you wish you knew when you were working for investors?

A: As an asset manager, I had strong skills in modeling deals and negotiating leases. But the best deals were those which were win-win for landlord and tenant. I knew I lacked an intimate understanding of the drivers behind tenant decision-making, and how those drivers varied based on the type of organization the tenant was – EBITDA focused? Cash is king? P&L? This year's P&L only? My first foray to the occupier side of the table was one long series of epiphanies!

Q: Chubb is your first position true 'in house' provider. What do you know now, that you wished you knew then when you were working as a service provider?

A: I'm still new to this role, so the learning opportunities are a daily diet. I will say that as a service provider I did not appreciate the complexity of navigating decision-making in a large corporate -- the process of aligning direction and activities across a highly-matrixed group of stakeholders with both common and disparate interests.

Q: Final Thoughts?

A: I joined the CoreNet Global Philadelphia University Relations committee because I believe those practicing corporate real estate do not do enough to expose young talent to the wonder and variety of careers with occupiers. I've most enjoyed exposure to the students, many of whom had no idea before CoreNet's introduction that the field of corporate real estate even existed as a career path.
