EMBEDDING THE **CDT** IN COMMUNITY COLLEGE DEGREE PROGRAMS

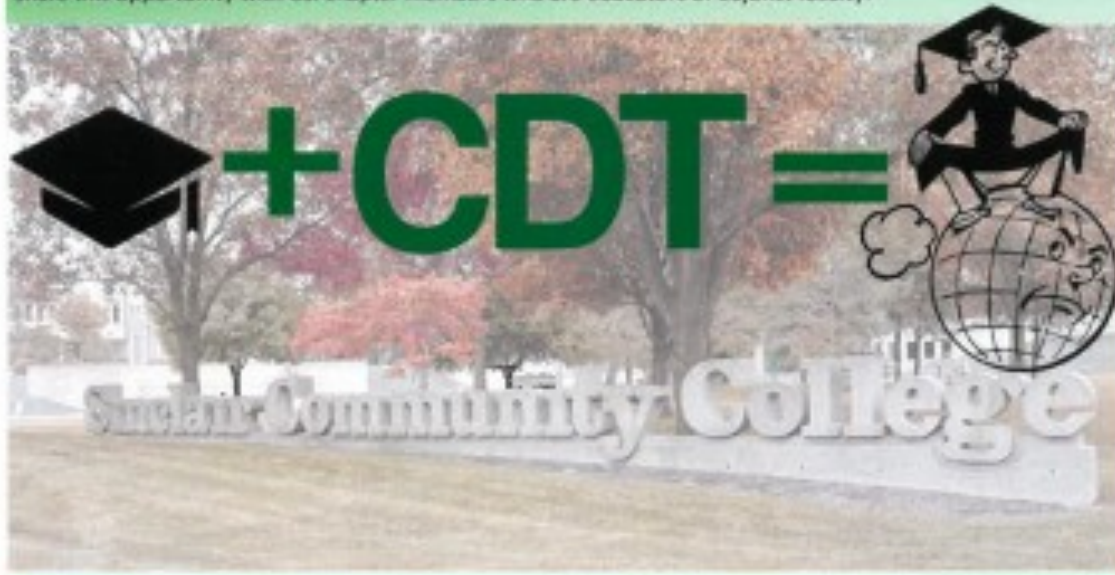
Increasing Technician Preparedness in the Built Environment

The project will transform associate degree programs by embedding critical STEM and industry standards from the Construction Document Technologist (CDT) into two-year education programs. The CDT credential was chosen because it is recognized by employers as a respected entry-level credential and it addresses significant gaps in undergraduate education. This program will help community college students earn the CDT credential while they are still in school.

The project will develop and disseminate new curricular modules for undergraduate students enrolled in architectural technician and construction management associate degree programs and provide professional development for community college faculty and staff. The project outcomes will be useful to other institutions with educational programs in the built environment that are struggling to diversify their student populations, and it will also be useful to those needing to update their curriculum to meet the changing needs in the industry. There is also direct value to student and graduate job-seekers who will be better able to certify their knowledge and skills to employers.

Professional Development Opportunity for Community College Built Environment Faculty

Summer Institute May 21 – 24, 2018

Spend four days on the Sinclair Community College campus developing and aligning enhanced curriculum modules to the seven Construction Document Technologist (CDT) knowledge areas to help students learn the basics of the CDT certification. Curriculum and content experts will help faculty align existing courses with CDT principles, as well as develop strategies for diversity and inclusion for built environment programs. There is no cost for participation in this Institute; however, faculty or their institutions are responsible for the cost of travel, accommodations, and per diem expenses. A \$1,000 travel allowance from the National Science Foundation grant will be provided for each faculty participant to help defray expenses. All or most of the expenses should be covered by the allowance.

Optional evening activities will be available and coordinated by the Institute.

Community College Student Benefits

As colleges implement the enhanced built environment curriculum, their students will be eligible to take the Construction Document Technologist (CDT) examination at no cost for them. Students earning the CDT credential will have an industry-recognized acknowledgement of the quality and depth of their skills. Students will be reimbursed for the cost of the exam, regardless of their pass/fail result.
