Continuing the highlights from the Winter Institute Board Meeting:

Plans are being finalized to make the CDT a Full Certification. Ever since Columbus State received the National Science Grant to make CDT a more robust platform to receive training of construction document training, plans have been moving to make the CDT a full certification by July 1, 2018. The CDT Certification will be for three years with expiration of June 30, 2021, unless renewed. Twenty-four hours of Continuing Education will also be required during this time frame as is currently required for the other certifications. Detailed CDT requirements will be issued shortly.

Plans are being finalized to allow reinstatement of CCS, CCCA, and CCPR Certifications for those who had not renewed their Certifications since 2014. Instructions from the Institute will be sent to those affected. There will be a period for application for re-certification verifying their continuing education units and paying a fee. Those Certificants granted recertification will have a valid Certification for three years that expires June 30, 2021.

Spring means it is time to consider those worthy Chapter members whose outstanding actions should merit a nomination for an Institute Award. Awards are the best way to thank deserving CSI members for their hard work that have made a difference in Chapter, Region, or Institute levels.
