RICHARD PAUL (Dick) BASTYR was born in Casper, Wyoming, in 1946. He attended DeLaSalle High School in Minneapolis, Minnesota, and Brainerd High School in Brainerd, Minnesota. He received an Associate of Arts degree from Brainerd Community College, and a Bachelor of Arts degree from St. Mary's College, both institutions in Minnesota.

Dick was a construction specification writer who worked for many architectural firms in Fargo, North Dakota, Monroe, Louisiana, Minneapolis, Minnesota, La Crosse, Wisconsin, and a few others.

During his service to the construction industry and CSI, his contributions in the technical field were significant. He authored 23 Spec Guide documents and 49 Technical Aid

Series documents; he also updated 48 Technical Aid Series documents.

Dick was a charter member and president of three CSI chapters: La Crosse, Monroe, and North Dakota/Red River Valley.

Bastyr was active in education. He was an instructor for the Minneapolis-St. Paul Chapter of the National Association of Women in Construction from 1984 to 1990. He also developed and presented a blueprint reading class for the La Crosse Builders Exchange for seven years.

After a career as a construction specifier and estimator, Dick retired, and lived in La Crosse, Wisconsin.
