DAVID METZGER is Vice-President of Heller & Metzger PC, an independent specifications consulting firm in Washington DC. He has prepared project manuals for more than 200 projects across the country, including Yerba Buena Gardens in San Francisco; the United States Olympic Training Center in Colorado Springs; and Concert Hall and Opera House renovations at the Kennedy Center for the Performing Arts, the Asia Trail at the National Zoo, and the National World War II Memorial, all in Washington, DC.

As a specifications consultant, Dave found the ideal position to combine his commitment to integrating the aesthetic and technical aspects of architecture with his interest in teaching and sharing his experience and knowledge. He previously was a professor of architecture at Oklahoma State University and at Thames Polytechnic in London, England, and continues to mentor younger members of the profession and architectural students. He teaches preparatory classes for CDT courses and for intern architects studying for registration exams; has lectured at CSI Conventions, CSI University, other conferences, and at schools of architecture; and serves as academic liaison for his CSI chapter. He served on the University of Michigan College of Architecture and

Urban Planning Alumni Board of Governors for eight years, and has been on the College's Campaign Advisory Committee since 2001.

Dave was chair of the AIA MasterSpec Architectural Review Committee for 2002 and 2003, and has served on this Committee since 1992. He has been Treasurer and Membership Chair of Specifications Consultants in Independent Practice (SCIP) since 1998.

Metzger received a B. Arch with Distinction from the University of Michigan, and an MS in Architectural Science from Cornell. Dave and his wife Carole have been married since 1967. His interests include photography (he has had two photographs published in national AIA calendars), driving his 1988 Alfa Romeo Spider convertible, and drinking single malt Scotch whisky (not at the same time).
