RON GEREN is an Arizona native, born in Tucson. He spent his precollege years in Tucson, Phoenix, and finally Yuma, where he graduated high school with honors. He returned to his birthplace to attend the University of Arizona, where he earned his Bachelor of Architecture and a commission as a second lieutenant in the United States Air Force.

After graduation, Ron spent four years on active duty with the Air Force as an architect, with assignments to Cannon AFB, Clovis, NM, and Davis-Monthan AFB, Tucson, AZ. After completing his commitment to the Air Force, Ron transferred his commission to the Air Force Reserve, where he served for the next 19 years until his retirement as a lieutenant colonel in 2007. As a reservist, Ron was activated and deployed to Kuwait in support of Operations Iraqi Freedom and Enduring Freedom.

After his active-duty military commitment, Ron returned to the civilian architecture market and obtained a couple of short-term positions with the State of Arizona and a small architectural office. During that time, Ron obtained his license as a registered architect in the State of Arizona. He later moved into positions of greater responsibility as an owner's representative for Arizona State University (ASU) and the Arizona Department of Emergency and Military Affairs.

Ron left public service in 1997 to accept a position at the local emerging office of Kansas-based Gould Evans Associates. While employed at Gould Evans, Ron prepared the specifications for the projects he managed, decided he needed a greater understanding of specifications, and joined CSI. After a few years, Ron became involved in the Phoenix Chapter, starting in the position of Programs Chair, a position

he held for three years. Ron eventually became involved on the chapter board as second vice president in FY 2005, which eventually led to his election as president of the chapter in FY 2008.

In addition to his leadership roles, Ron has provided many other services to the Phoenix Chapter, including teaching the chapter's CDT preparatory seminar for the past seven years.
