ED AVINK started his career working at Daverman Associates, a large architectural firm in Grand Rapids, Michigan, in 1973. When assigned to an architectural team, he was placed between two seasoned architects and enjoyed the one-on-one mentorship that occurred. Opportunities were given to grow and become a leader and mentor to others. Part of the opportunities came from a charter member of the Grand Rapids Chapter, and the invitation to join CSI. That was the beginning of Ed's involvement with CSI and membership, in 1987.

After 15 years at Daverman Associates, Ed was invited to join Progressive AE, a newly formed full-service firm in Grand Rapids, to take on leadership with technical guidance, specifications, and project management. With the support of CSI and Progressive AE, CSI principles and standards became a part of business. As a result, more than 80 employees earned their CDT. Many that have moved on are promoting CDT within their new firms. Though having had many titles in the firm, the title Senior Technical Leader – Specification Manager is a direct result of CSI's influence. That influence is on the firm's 250 employees in two offices: Grand Rapids, Michigan, and Charlotte, North Carolina.

Certification has been Ed's passion for many years, and his giving back to the industry has grown over the years. From

teaching CDT classes and proctoring the Saturday morning exams, to going virtual (in part due to the COVID pandemic), his techniques have evolved. He had 65 students from across the country in the Spring 2021 CDT exam preparatory classes.

Ed has over 30 years of active leadership participation at chapter, region, and Institute levels. For the Grand Rapids Chapter, he has held the positions of President, President-Elect, Director, and multiple committee chairs including Newsletter, Advertising, Membership, Technical, and Certification. At the region level, he has served multiple years as either Technical or Certification Chair. At the Institute level, he has made numerous contributions to CDT training, and was recognized for his contributions in the Project Delivery Practice Guide (PDPG) 3<sup>rd</sup> Edition Study Workbook.
