



The Value of Meeting Face to Face

Every year I have the conversation with myself about the value of going to regional and national convention. As convention nears my family starts to get nervous about Mom being gone for a week and I try frantically to finish enough work so I can focus on education and networking while I'm there. I start to dread the plane flights and the cab rides and the feeling I get from too much food and too little water and exercise. I start to add up the cost for lost production hours, the hotel, the food and the plane flight and I start to question if it is really worth it.

Then I go to convention and I realize again that it is worth it. I reconnect with people doing the same thing I'm doing only in California, Canada and Florida. I learn about their new ideas that they arrived at because they are looking at the world from a slightly different perspective. I trade my preliminary project description files for specifications about delegated design. I get ideas from other chapter leaders that are doing new things in their CSI chapters. I present my ideas about the future of specifications and get feedback that allows me to broaden my thinking. I chat with an attorney about design assist over lunch and learn something I would never have figured out on my own. I wonder around the show floor and run into the product rep for roof pedestals and learn why I would spec one system vs the other. I see a product I didn't know existed that allows a project team to pour, stain, and polish underlayment over cross laminated timber so areas of a building can look like concrete. Read More.


