CSI is hosting the room for this ASHRAE Chapter Meeting, during which Kjell Anderson (AIA, LMN Architects) will present the intersection between Architecture and energy modeling.

We know we need to collaborate early in the design process to achieve radical energy efficiency improvements, but we as an industry we have not figured out the best way to do this. Architects ask 'how is this performing?' and want various geometries compared with immediate answers; modelers want detailed data and enough time to perform simulations. Architects often fail to understand the

Architects, in many cases, never even meet the energy modeler on their project. We can drastically improve project performance by focusing on the relationship between architects and energy modelers: forging a better process as outlined in ASHRAE 209, understanding each other's language and constraints, learning to ask the right questions, and realizing the amazing things we can accomplish together.

Kjell is an Architect and the Sustainability Coordinator at LMN Architects, recipient of the 2016 AIA Architecture Firm award. He is a licensed architect, speaker and author of "Design Energy Simulation for Architects." In addition to regular design work on LMN's projects, he serves on the AIA Energy Leadership Group, is involved in energy code-writing projects, and has taught building simulation at the University of Washington.

Getting started with materials transparency can be intimidating: you have to understand LEED v4, Living Building Challenge, Mindful Materials, EPDs, HPDs, Declare Labels, various Red Lists... and the list continues. Join Ed Clark (Associate Partner at ZGF Architects; LEED AP), Melissa Balestri (Associate at ZGF Architects; CCS) and Chris Hellstern (The Miller Hull Partnership; LFA, LEED AP BD+C, CDT) as they demystify the transparency movement and present the current state of the materials landscape. They will discuss both national and local efforts, as well as their firm's internal efforts. ZGF Architects was recently ranked number 1 in the country both overall and in the sustainability category by Architect Magazine. 

As part of an update of approved abbreviations, my office changed its long-standing ACB (acoustic ceiling board) to ACT (acoustic ceiling tile). Before coming to this office I had always seen ACT, and it took a bit of time to get accustomed to ACB. No one knows where this unusual abbreviation came from, but it is the more logical of the two, as it includes both acoustic ceiling tile and acoustic ceiling panels. Still, it was decided to change from ACB to ACT because ACB is unusual. I doubt many contractors will ask an architect, "What's ACT?" but it has not been uncommon for contractors, subs, or suppliers to ask us what ACB is.
