May Program Recap: Evolve the Specifier

Beth Stroshane and Marc Chavez spoke at the May dinner meeting about how the specifier can evolve to become more valuable in the rapidly changing construction industry. The metaphor used was that building a project is like playing a deck of cards, and as the industry has become more complex, the result has been more bluffing in the game. The contractor has gotten involved earlier in the process and begun taking aggressive steps to independently deliver the project to the owner. Now decisions are being made without the architect, and no one is playing with a full deck of cards. There is an opportunity for specifiers to step in and take the role of coordinating information between the architect and contractor, which importantly, does not necessarily mean working for an architect. The audience was very engaged in the presentation and made some great comments. Let's keep the conversation going!









What the difference between drawings and specifications?

We all know what specifications and drawings are. Or do we?

In casual conversation, it's not unusual to hear someone say "the specs" or "the specifications" when referring to the project manual.

Similarly, it's common for people to say "the drawings" when referring



to, well, the drawings. In either case, it's almost certain that everyone's mental images are of documents in two sizes: 8-1/2 by 11, and 30 by 42, or some other large size.

What's wrong with that? Nothing - except that paper size has nothing to do with what's on the paper. Yet because of the way we have printed documents for decades, we suffer from a common preconception. I'm as guilty as anyone; I often have used the acronym SPDNORUTT - small paper documents no one reads until they're in trouble - when referring to the project manual. Again, what's wrong with that? Aren't specifications printed on small pages, and drawings on large sheets?
