# President's Message

CSI should be *indispensable* to its members and the industry." -- Mark Dorsey, C.S.I. Executive Director; St. Louis, MO 2015. Historically, the nature of CSI professionals will defer to the process, show respect for the written



documentation, apply diligence in assessing a potential problem and reduce the potential risk to the project. I was somewhat surprised by many CONSTRUCT presentations which contained bold thinking, new ideas for future construction methods, collaborative project delivery models, and challenged the very future of CSI itself. From 3-D printing of new buildings (full-scale), to tapping the disposition of 'Gen Z' as we gear up for constructing the future, CONSTRUCT 2015 was distinctive from other national A/E/C shows in that it allowed for consideration of blue sky concepts against the backdrop of experienced professionals all steeped in the realities of construction.

Back to Mark Dorsey's statement: What about CSI is indispensable to me? I am not sure. I am leaning toward this idea that as my 'sectional existence' within Division 03, 07 and 09, becomes increasingly interwoven with other sections and products, I need more knowledge and resources. I can't keep up with everything in construction, but I have access to the best knowledge network for anything that touches my products. And I am mindful that this is a personal network, not something contrived from LinkedIn. That connection provides me, and by proxy my company, with greater adaptability and growth potential as things continuously change. Since I can't get that from my other professional organizations, and I really must have that knowledge network to thrive in a competitive landscape, that is indispensable.

Contractors Forget

If you're really aiming to be indispensable, then you should build it upon something that cannot be easily copied or reproduced by another organization. Ask yourself what substantively differentiates CSI from other professional architectural, engineering and manufacturing organizations?

Is there a common strain of DNA amongst CSI chapters? As a member at 7 different chapters through the years, I would say "yes" there is. It is the gene for both **inclusiveness and sharing.** 

### 1. Diverse Inclusivity

CSI is unique in the industry in that its members are a cross section of architects, engineers, designers, specifiers, contractors, owners, facility managers, building materials suppliers, and others who are touched by construction documentation. The all-inclusive sum of these perspectives ensures more <u>realistic</u>, accurate, and applicable <u>building documents</u>. Attitudes and egos have to be set aside to allow this type of diversity; CSI is a great forum for improvement of construction documentation.

### 2. Knowledge Sharing Culture

There's an unofficial fraternal order of specification writers that came together after WWII and created the foundation of this knowledge sharing culture. That culture survives today and despite the perpetual pressure of project deadlines, they somehow make time for others and are eager to share their thoughts and advice. Somehow it has rubbed off on our engineers, consultants, and product reps. Rather that put up barriers around our work, our group helps its colleagues, with actions such as pointing them toward another specification writer, a trusted product rep, a code specialist or a great consultant, or helping somebody find a new job when the economy tanks. These are both unique and defensible traits of our organization. We owe a debt of gratitude to past leaders and Emeritus members for this inheritance.

Heads up to our manufacturers! This is your insiders' tip of the century. If your company is or wants to be a truly national brand in commercial construction, then, make sure your company budgets for CONSTRUCT 2016 being held in September 8-10, 2016 in Austin, TX.

CSI's CONSTRUCT show is the greatest value of any national trade show. Tell your marketing department to throw away the traditional trade show metrics. The average CSI show attendee is much more likely to be influential in product selection and application. They are consultants, specifiers or technically minded architects who want substance and knowledge; they are not so interested in spokesmodels giving out free golf balls (check that..Ed Storer may want the golf ball and competent reps who hand out golf balls). If you believe in quality over quantity at trade-shows, then bring your "A-Team" of technical representatives and save the money allocated for models that don't know how your product works. 

Andrew Marks, PE, Managing Director of the Puget Sound Concrete Specification Council, presented our October Dinner Program on pervious concrete and provided free copies of ACI 522 to eight lucky attendees. He taught us that uniformity is important for strength, especially as strength and porosity are in direct competition with one another. Porous concrete must be designed weaker than conventional concrete, though added strength may be achieved through increasing the assembly thickness. He also stressed that plastic sheeting is required for curing, and that there is currently no valid ASTM test for pervious concrete. Many thanks to Andrew, who was a fantastic presenter.

# Tell me again part 2

In "Tell me again part 1" we looked at how proper use of reference standards can reduce the amount of text required by making those standards part of the specifications. Going back to the "say it once" principal, proper use of Division 00 and Division 01 can go a long way toward eliminating needless text.

In the good old days, it was common to include at the beginning of every specification section a statement similar to this: "Drawings and General Provisions of the Contract, including General and Supplementary Conditions and Division - 1 Specification Sections, apply to this Section."
