



2017 Delegate Application for General Assembly

Each State shall be entitled to one (1) voting delegate that shall be the State Council President or designee. There shall be additional delegate and alternate positions assigned by National ENA. A member registered as an alternate delegate may be transferred from alternate status to delegate status at any time during the General

Assembly. Every alternate should be prepared to assume delegate status and therefore has the same obligations as a delegate. Delegates and alternates must attend all business sessions and special delegate activities at the General Assembly, attend the designated mandatory meeting (August) of the NJ State Council to discuss resolutions, and complete the General Assembly orientation.
