

CTENA GA/ DELEGATE SELECTION POINT SYSTEM

The CTENA Delegate Selection Point System allows for active CT ENA voting members to represent at the National General Assembly. Selection criteria will reflect their CTENA/ENA activities from June 1st of the previous year through May 31st of the current year.

Delegate electronic applications will open on the first Monday of April of the current year.

All delegates must attend the August State Council meeting prior to the General Assembly to prepare. There are no exceptions to this. By filling out the application, you are agreeing to attend the August State Council meeting and all sessions of the General Assembly if selected as a delegate.

- Our standard procedures permit the **President, President-Elect, Secretary, and Treasurer** to represent CT-ENA. If one of these members are unable to attend, they must notify the President prior to delegate selection.
- The remaining delegates will be selected by the CT ENA Executive Committee, not limited to using this point system.
- Participation is open to every CT ENA voting member.
- Application to be completed electronically no later than **June DD, YYYY** to be considered.
- *Purposeful misrepresentation of your application will result in immediate disqualification of the applicant.*

The CT ENA Executive Committee will meet, review applications, and select delegates based on the points system. This meeting shall occur no later than June 7th each year, and this meeting may be conducted by conference call, if needed.

Starting in 2027 CTENA will be moving to CALENDAR YEAR
