Be a Voice for Emergency Nurses

The Michigan Delegate group has just returned from sunny San Diego, California. It was not all fun and games, serious work was completed in the two-day General Assembly meeting. Unlike many professional organizations, ENA is self-governed. That means there is representation from all states as well as our international members. Proposals are submitted on initiatives that the membership would like ENA to spend time and resources on. We as delegates in Michigan spoke on your behalf on these issues. Here are some of the issues that were decided this year:

- ☐ ENA will now offer a virtual option for all future ENA conferences
- ☐ ENA will work on increased public awareness of Safe Haven options
- ☐ ENA will promote education on mitigation of pediatric window falls public awareness
- ☐ Focus on improving Emergency Department Team Member safety

☐ Rule changes on RN licensure requirements for ENA members (allowing retired
members who do not remain licensed to be active and vote)
☐ Supporting the use of the title "Doctor" for PHD prepared nurses in the academic setting
☐ Support for the placement of nasal naloxone on all airplanes and public
schools/universities
☐ Support for standardization of emergency equipment on all airlines, including epi auto-
injectors and nasal naloxone

In addition to these issues, there were 3 bylaw changes that were discussed and voted on. This conference is always a chance to network with emergency nurses and re-energize our practice (and have some fun and games!)

Why am I sharing all of this?

I would like each of you to consider the possibility of being a delegate. The selection is based on your activities that support emergency nursing. I am attaching the application tool that was used for 2023 so you can see what it takes. Delegates receive reimbursement on hotel as well as airfare and a daily allowance for incidentals. It is also a great way to offset the cost of attending the International Conference (since airfare is covered for delegates. You can also double your paid hotel nights by rooming with another delegate.) You will have some "down time" to enjoy the area and have some fun while you are there. 2024 will be in Las Vegas, NV on September 3rd and 4th. 

My experience as a member of a National ENA committee

At the suggestion of our Michigan ENA president, Rebecca VanStanton, I applied to be a member on ENA's National Emergency Nursing Advanced Practice Advisory Council. I haven't been an advanced practice provider for very long, as I worked in urgent care and have been picking up local ED RN contracts. When I wrote a letter applying to be a part of the committee, I was honest in what I thought to be my lack of experience as an Advanced Practice Provider. I also mentioned I believed my standing as a newer APRN might offer insight into what is needed to support those in my position. I was surprised when I was accepted. As a member of this council, we have reviewed position statements by ENA pertaining to APPs, as well as reviewing positions statements sent to ENA for support. Sometimes we recommend ENA support it, other times, we point out issues with the position statement and why it should not be supported by ENA. We are also involved in other projects involving stakeholders from other nursing organizations and physician groups to support APRNs in the workplace.

As a part of this committee, I have attended a zoom meeting every two months, and was able to attend an on-site meeting at ENA Headquarters in Schaumberg, Illinois. I was also asked to participate in the "Sharpen Your Skills" area at the National ENA Conference Experience Hall and participate in the APRN Meet and Greet while in San Diego.

This position is a two-year appointment and has thus far been rewarding to me to keep myself abreast of the latest trends in APRN practice and barriers that APRNs face. It has also been rewarding to be able to network with other APRNs and represent this rapidly changing career role with this organization.

I encourage anyone who is thinking about volunteering at a national level to review the opportunities and to apply for a position. It has been a rewarding experience for me to represent APRNs and ENA in this role.
