# ENA Quality, Safety and Injury Prevention (QSIP) Chair Role Description

The role of the State Council QSIP (formerly IQSIP) Chairpersons includes supporting and overseeing the quality and delivery of quality, safety, and injury prevention initiatives and activities.

#### Responsibilities and activities include:

- 1. Promotes quality, safety, and injury prevention efforts
  - · To be integrated into every day nursing practice
  - To become leaders within institutions and communities
- 2. Establishes and maintains initiatives of the ENA Quality and Safety department at the state level
- Maintains communications about quality, safety and injury prevention with ENA state council and chapter leaders, volunteers and ENA headquarters
- Works in collaboration with ENA state council president and treasurer to plan for adequate resources to maintain or expand quality, safety, and injury prevention efforts
- Explores funding opportunities by pursuing local grant proposals and responding to and disseminating requests for proposals within their state
- 6. Networks within the state and with other similar organizations to advance quality, safety and injury prevention in venues such as:
  - · National or local meetings, coalitions, and task forces
  - ENA State Council/local chapter meetings
  - ENA Emergency Nursing Conference
- 7. Other duties may include:
  - Provides knowledgeable content on local and state quality, safety, and injury prevention issues
  - Provides informed feedback on proposed quality, safety, and injury prevention measures and initiatives
  - Participates in quality, safety, and injury prevention advocacy efforts
  - · Contributes to publicity efforts with state public relations and media contacts

#### Qualifications for the Quality, Safety and Injury Prevention State Chair:

- Current ENA Member
- Current registered nurse licensure
- Demonstrated leadership through previous or current involvement in chapter, state council, or national ENA projects, committees, or programs
- Knowledge of quality, safety, and/or injury prevention

### The following outlines various attributes this role should encompass:

- Demonstrates leadership skills
- Current certifications preferred (e.g. CEN, CPEN, TCRN)
- · 3-5 years experience in quality, safety or injury prevention programs or initiatives

### **Foundation Update**

In 2021, ENA Foundation celebrated their 30<sup>th</sup> anniversary supporting academic scholarships for emergency nurses. Educational opportunities are so important in our ever-changing nursing world. ENA Foundation and the MENA Foundation has been an important resource for emergency nurses to pursue higher education support.

I am proud to chair the MENA Foundation committee raising donations and supporting emergency nurses with scholarship opportunities. Being able to provide scholarships to individuals to reach higher levels of nursing education is very important to ENA at the state and national levels. This year, MENA sent 8 board members to the leadership conference in Charleston, South Caroline. By generous donations from our fellow nursing peers and state chapter pledges, the ENA Foundation was able to raise over \$165,000.00 to support scholarship opportunities to its members. This was the start of the Foundations annual 2022 scholarship campaign. Their goal is to provide as many scholarships as they can to help emergency nurses.

The ENA Foundation gives \$5000.00- and \$10,000.00-dollar scholarships to those who apply and get selected based on qualifications specified in the application process. There are other scholarship opportunities that can be obtained as well. Last year ENA gave out more than 20 scholarships.

MENA Foundation also gives out a one-time \$500.00 scholarship to emergency nurses who are pursuing a higher degree. You can go to the ENA website and the MENA website for information on how to apply for scholarships. We have had several of our own members selected for the \$5000.00 scholarship. I was one of the nurses selected by ENA to assist me with my master's program.
