

URGENT REQUEST FOR HELP

House Bills (HB) 4520 and 4521, were recently introduced by Rep. Mike Mueller (R-Linden) and Rep. Kelly Breen (D-Novi) to help protect healthcare employees including nurses while performing their official duties. While not making these assaults a felony (which seems to have been a sticking point in getting the bills passed) the bills double the fines, and require signage be prominently placed in hospital emergency rooms to deter potential assaults. Our MENA government affairs committee reviewed these bills at our last meeting and support the bills. We encourage all our members to contact your local house representatives and ask that they support the bills. If you do not know how to do this, please contact Naomi at Nurseomi@comcast.net, she will help you write an email or a plan a visit and has offered to accompany you on your visit if she can.



Government Affairs Update

May 2-3 was the ENA National Day on the Hill this year. I had the opportunity and honor to represent our Michigan ENA in Washington D.C. for this event. The event started off with ENA staff, national board members, and ENA Government Relations staff Rob Kramer and Richard Mereu provided us with a preparation day which included a comprehensive review of the ENA's government affairs priorities, and a summary of the 2 bills that we are currently backing, as well as how to effectively speak to our representatives. IN addition, they spoke about how to effectively use social media to promote our messages

The Deputy surgeon General Denise Hintion who is a nurse, and passionate about improving mental health care across the nation. She acknowledged the increase in violence and general incivility that seems to be pervading the nation, and spoke of several initiatives that their office is working on to improve physical and mental wellbeing of the nation's youth, as well as initiatives she is supporting to improve workplace safety and decrease violence in mental health care institutions.

On day 2, we went to the Capitol and met with our legislators. I was able to meet with Senator Gary peters and his staff, as well the health aides for Senator Debbie Stabinaw and House Representative John James. They were all very supportive of the ideas behind both of the bills that we were asked to speak to.

This year we were there specifically supporting 2 different bills. The first is HR 2663/S.117 the "Support the Workplace Violence Prevention for Health Care and Social Service Workers Act." This bill directs the secretary of Labor through OSHA to require employers to develop and implement prevention plans that are worker driven and comprehensive, based on a hazard assessment that workers are a part of. This would include creating a process of documenting and investigating violence, supporting employees who report instances of violence including non-retaliation strategies, and ensuring training in identifying and addressing hazards, and ensuring that employees are aware of their rights to report to the authorities. Senator Debbie Stabinaw was an immediate cosponsor, and Senator Gary Peter's office stated they would be signing on

The second bill is the "Improving Mental Health Access from the Emergency Department Act" which is the S.1346 (not yet introduced in the house) bill. This bill is specifically trying to address the extended holding of mental health patients by creating funding for programs that expedite transition to post emergency care through use of tele-psychiatric support, or assessment in the ED by community health care programs to place them in outpatient crisis clinics, as well as increasing the number of available inpatient beds. All three offices were not aware of this bill, but all three were very interested and stated that it was likely that he would be supportive of such legislation. While none have signed on yet, I have reached out to the staff to remind them about it and again asked them to support it.

The day was capped off with a joint press conference with ENA and the American College of Emergency Physicians (ACEP) who was also in Washington DC to support the legislation. This was held on the lawn of the capitol building and several nurses and doctors shared their stories of being violently attacked at work, and how it is affecting morale and making it more difficult to recruit and retain staff for the emergency departments across the country. Through advocacy and asking for change we can create an environment that is safe and supportive for our staff who

work in our Emergency departments which are a vital part of our healthcare system, and a safety net for many who need care across the country.
