

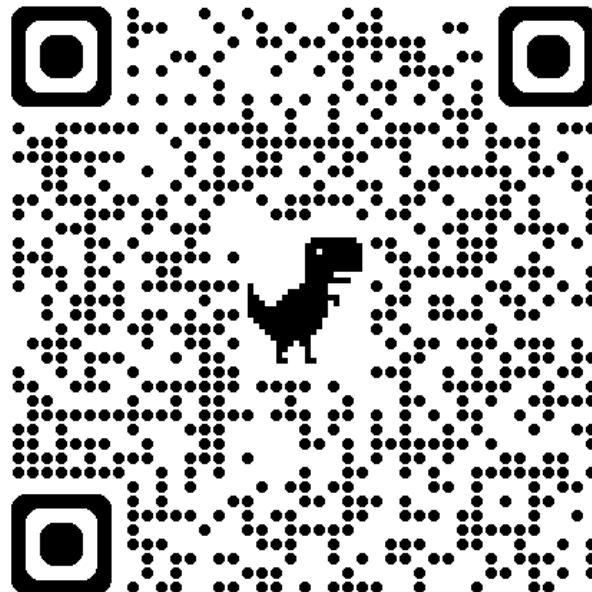

WHAT IS REGISTERED APPRENTICESHIP?

A Registered Apprenticeship is a formal, state-approved training model that combines paid On-the-Job Training (OJT) under an experienced journeyworker with Related Technical Instruction (RTI) – structured classroom or online coursework tied directly to the occupation. Apprentices are employees, not students in the traditional sense: they're hired, paid, and progress through a documented wage schedule as they master defined competencies, until they earn a state-registered Certificate of Completion of Apprenticeship.

WHY ADVANCED MANUFACTURING NEEDS IT

Robotics, semiconductor fabrication, PLC-driven automation, and Industry 4.0 systems require skills that most traditional degree timelines can't keep pace with. ROOTS apprenticeships close that gap: employers train technicians on their own equipment, on a documented, state-recognized standard, while apprentices earn a paycheck and a credential instead of a tuition bill – a future-proof investment for everyone at the table.

HOW THE ROOTS APPRENTICESHIP MODEL WORKS

Every ROOTS apprentice moves through three connected components at once:

- **On-the-Job Training (OJT):** Paid, supervised work experience with a qualified journeyworker at a participating employer, building toward a defined total-hours requirement specific to the occupation.
- **Related Technical Instruction (RTI):** A minimum of 144 hours per year of structured coursework delivered in a hybrid model (online and in-person) through ROOTS or a partner technical college enhancing the technical knowledge behind the OJT work. ROOTS can build customized RTI to meet your business's unique skills.
- **Credentialing:** Upon completing both, the apprentice earns a state-registered Certificate of Completion of Apprenticeship from the Florida Department of Education — one step in a multi-certification pathway recognized across Florida's registered apprenticeship system.

EMPLOYER RESPONSIBILITIES

- Hire and pay the apprentice
- Assign a qualified journeyworker to supervise OJT
- Maintain a 3:1 apprentice-to-journeyworker ratio
- Document and approve OJT hours and competencies
- Provide safe working conditions and required safety training
- Support the apprentice's release time for RTI where applicable

APPRENTICE RESPONSIBILITIES

- Complete the required OJT and RTI hours
- Meet minimum eligibility (age 18+, HS diploma/GED, ability to lift/carry 50 lbs, English proficiency for safety and instruction)
- Complete a 90-day probationary period
- Follow all safety standards
- Maintain satisfactory performance and attendance in both OJT and RTI
- Work toward the Certificate of Completion of Apprenticeship

EMPLOYER IMPLEMENTATION

1	Consultation	Discuss your equipment, roles, and hiring needs with ROOTS
2	Sponsor agreement	Sign a <i>Participating Employer Agreement</i> with ROOTS's (no need to register your own program)
3	Recruit or designate apprentices	Hire new apprentices or enroll existing employees
4	Assign a Journeyworker & begin OJT	ROOTS provides the documentation framework
5	Coordinate RTI enrollment and access	Through ROOTS or a partner technical college
6	Track progress	ROOTS maintains the required records

APPRENTICE JOURNEY

1	Meet minimum eligibility	18+ years old, HS diploma/GED, can lift/carry 50+ lbs., and can read/write/speak English
2	Submit an interest form	Complete the form online HERE
3	Get matched with an employer	ROOTS shares your resume with businesses
4	Get hired and begin paid OJT	Once employed, your OJT clock starts when you are an officially registered apprentice through ROOTS (and if applicable, your technical college)
5	Start RTI coursework	Begin working through RTI requirements
6	Complete the 90-day probationary period	Successfully finish 90 days in good standing
7	Advance through the program	Continue employment and RTI progress
8	Earn credentials & wage increases	Complete the program requirements

FUNDING MECHANISMS

ROOTS partners with technical colleges, regional workforce boards like CareerSource, and the Florida Department of Education's Apprenticeship office to build a documented, fundable pipeline into advanced manufacturing careers.

- **Technical College partners** retain 100% of District Workforce Education Funding and Performance-Based funding tied to apprenticeship FTE enrollment and industry certifications earned. Apprentices must complete the technical college's registration procedures.
- **Every Apprentice is employed from day one**, counting as a positive placement outcome for accreditation and workforce reporting.
- **The multi-certification pathway** is designed to support grant funding justification for education partners.
- **Potential employer incentives include** state/federal apprenticeship tax credits, grant eligibility, and cost reimbursement for program participation through regional workforce boards.

OUTCOMES AND REPORTING

ROOTS maintains all required Florida Division of Workforce Development Office of Apprenticeship (DWDA) and Department of Education training records, including OJT credential files, for every apprentice and participating employer, and reports program status to its assigned Apprenticeship Training Representative.

- **Is this a real job or a school program?** Both — apprentices are hired, paid employees who also complete required coursework.
- **How long does it take?** The Robotics Technician registered occupation is a 2-year program and requires 4,000 OJT hours.
- **What does it cost an employer?** Employers pay apprentice wages during OJT — ask during your consultation about current partnership terms and funding options.
- **Who is eligible?** Applicants must be at least 18, hold a high school diploma or GED, meet physical requirements (ability to lift/carry 50 lbs), and meet English-language requirements for safety and instruction. Veterans with qualifying discharge status and Florida Registered Preapprentice graduates receive selection priority.
- **Where is this available?** Employers and schools anywhere in Florida can participate.
