The Foundation had a visible presence at the FRPA Annual Conference as attendees entered the hall into the classrooms and in the exhibit hall. Volunteers worked on behalf of the Foundation to assist with networking with conference delegates in a fun environment, and generated excitement with new ways for contributing to the Foundation, including a balloon pop for gift cards, card shark, and “big ticket” items.

This year, the Foundation continued our new format for the Annual Auction, and offered a silent auction held in the Exhibit Hall. 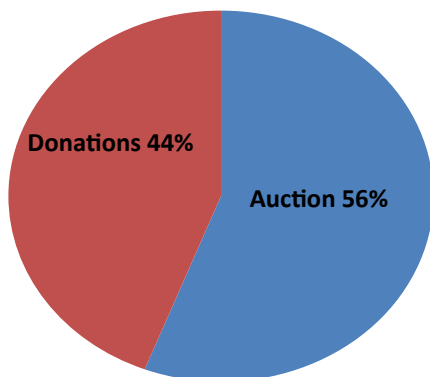

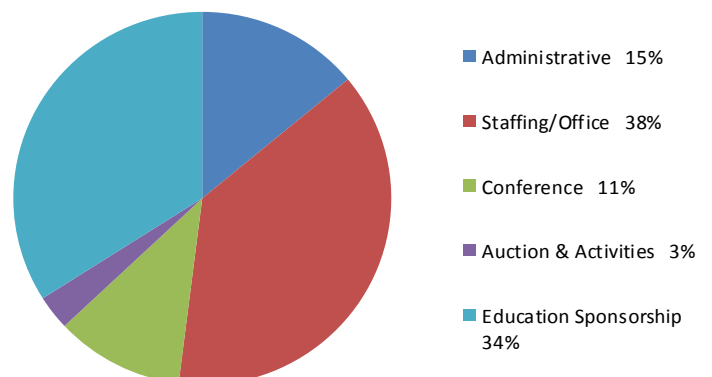
