Business Meeting Summary:

Convened on 31 October 2011 with 10 members in attendance in addition to the 4 officers.

Discussion of membership continuing to decrease and remedies to bolster membership, especially student membership and promotion of scholarships available. Continued success of Jahns lectureship in reaching student audiences; international lectures were more prominent than in previous years. Reviews in Engineering Geology series continues with success, two are in work. Committees all listed above were subject of discussion and their impact on the health of the division. Cooperation with

AEG on a multitude of fronts can provide avenues of health for EGD – the academics AND practical applications sides are BOTH worthy of investigation. New newsletter editor stepped forward to take the reins from Jerry DeGraff. The possibility of a name change for the division was once again brought up, and after some discussion it was decided to change the division name. Actions were then put in motion to effect that change. Competencies for engineering geologists were raised as the IAEG and the AEG evaluating a document outlining competency recommendations for engineering geologists. EGD should have a committee to review those documents as well, since US visibility in the IAEG has increased in recent years.
