Dr. Kennedy came to CHAP in 2021 with a vision of moving the organization's quality forward as "the" accreditation partner of choice for the majority of community-based providers. She believes no matter what type of care a patient receives or how many times they receive care, every experience should be of the highest quality. Kennedy leads the CHAP quality team and interacts with CMS related to regulatory and quality issues. Dr. Kennedy has a doctoral degree in health care education and policy, a dual master's degree in health education and case management, a bachelor's degree in nursing, and is a certified healthcare compliance professional.

#### **Session Summary:**

CMS has revised the State Operations Manual Appendix M for hospice providers and surveyors. Updates to the content are based on hospice program integrity updates in the FY 2022 Home Health payment update rule and the 2019 Burden reduction rule. This session will review "must know highlights" of the Appendix M revision including the revised survey protocol for hospice compliance surveys and L-tag changes.

Up-front management of the Revenue Cycle can serve to minimize claims payment challenges. Interestingly, these same disciplines serve to support care quality, particularly driven by authorization compliance, care plan integrity, and timely visit verification. We'll discuss how this all weaves together, and the benefits derived in this regard by a robust, full-featured agency management system.

Hospices are often faced with the challenge of admitting patients who are on anticoagulants, often for diagnoses that are only indirectly related to the terminal diagnosis. Questions about medical necessity, risk/benefit, and inclusion in the hospice benefit are not directly addressed in medical literature. This session will review the outcomes data and risk/benefit profile of these medications to help hospice staff and clinicians make informed, data-driven decisions about continuing these medications for patients in hospice care.

## End-of-Life Planning and the Importance of Informed Decision Making Erin Silvers, Anatomy Gifts Registry Room 16 Hospice

Erin has been a donor services coordinator at Anatomy Gifts Registry for 2 years. Being a donor services coordinator entails assisting grieving families through the process of registering their loved one for whole body donation. We also work with healthy applicants that are interested in donation for the future instead of traditional arrangements such as burial or direct cremation. I truly enjoy being able to help others and being at AGR. Losing a loved one is never an easy thing to go through so being able to support families in such a difficult time in such an impactful way by donating to advance research and education makes my career so meaningful. The mission we have at AGR is "One Gift. Countless Opportunities" every donation is advancing medicine, research and education for the future.

Session Summary: Discussing end of life arrangements/plans is beneficial for the home care professionals/hospice and the family eliminating the stress of needing to make decisions at time of death when the families are already grieving the loss of a loved one. Discussing the benefits of pre-planning and the options available to families/patients and the estimated costs for the arrangements allows them to make an informed decision for patients/families to ensure they are making the right choice for themselves/a loved one. Discussing the difference between organ donation and body donation with the understanding organ donation does not automatically enroll someone for body donation and that whole body donation is still an option when organ/eye/tissue donation has occurred.

Brad was awarded the 2013 National Award for Hospice and Palliative Care Nurse of the Year through the National Board for Certification of Hospice and Palliative Care Nurses for his contributions to the field of hospice. He has presented and educated on issues related to the end of life and symptom management throughout the country and internationally for more than a decade. He has contributed to research in the field including publications in the Journal of Pain and Symptom Management and the Journal of Hospice and Palliative Nursing. He received a special major B.A. in psycho-physiology from California State University, Long Beach in 1987, and a B.S. in Nursing from the University of San Francisco in 1989.

#### Session Summary:

The last days of life bring changes that make assessment and treatment of symptoms more challenging. As level of consciousness decreases patients become unable to self-report symptoms. Multiple organ shutdown including brain, kidney, liver, and bowels make medication management more challenging. Being able to quickly identify symptoms and effectively treating them is of utmost importance in providing a good death outcome for the patient and family. This course reviews these challenges and discusses physiologic changes that must be considered when assessing patients, choosing medication, teaching caregivers, and deciding on effective routes of medication delivery in the last days of life.
