 - Common State Grants through ISBE that require an application and expenditure report through IWAS
 - School Maintenance Grant
 - After School Programs
 - Preschool for All
 - Early Childhood Block Grant
 - Library Grant state grant through Secretary of State



ISBE and IWAS and FRIS, oh my!

- Federal Dollars Program/Revenue Code 4xxx
 - Common Federal Grants through ISBE that require an application and expenditure report through IWAS
 - Every Student Succeeds Act (ESSA) Title I, Title II, Title IV
 - Title III
 - IDEA Consolidated IDEA Flow Through, CEIS, IDEA Preschool
 - McKinney Vento Reimbursement through ROE/ISC
 - Medicaid Reimbursement through Illinois Department of Healthcare and Family Services

2024 BOOKKEEPERS CONFERENCE

Title I, Part A – Improving the Academic Achievement of the Disadvantaged

- FRIS Program Code 4300
- Old names Title I Low Income, Title I Improving Basic Programs
- Purpose provide all children significant opportunity to receive fair, equitable, and high-quality education, and to close achievement gaps
- Examples of allowable items: paraprofessionals, tutoring, family engagement nights, instructional
 or assessment software, classroom libraries, summer school, some professional development
- Examples of items not allowed: most large incentives (certificates, books are okay), home based internet service, food or complete meals (light refreshments are okay), construction, cell phones for personal use

2024 BOOKKEEPERS CONFERENCE

Title I, Part A, 1003 – School Improvement Grant

- FRIS Program Code 4331
- Awarded to specific school buildings that are identified as Targeted or Comprehensive on the District's report card.
- Similar to Title I, but each building must use an ISBE approved consultant.
 - Also known as IL-EMPOWER program



Title II, Part A – Preparing, Training, and Recruiting High-Quality Teachers, Principals, and Other School Leaders

- FRIS Program Code 4932
- Purpose To provide funds to increase academic achievement by reducing class size and elevating teacher quality through recruitment, hiring, and retention strategies
- Allowable items teacher salaries to reduce class size, new teacher/leader mentoring program, professional development, conferences (must be specifically approved in the grant), membership dues, job fairs, instructional coaches.
- Not allowed regular classroom teachers, paraprofessionals, tutors, food/meals/drinks for PD, employee awards

2024 BOOKKEEPERS CONFERENCE

Title IV, Student Support and Achievement (SSAE)

- FRIS Program Code 4400
- Purpose increase the capacity to:
 - Provide all students with access to a well rounded education
 - Improve access to foreign language, art, music, STEM, AP, etc.
 - College and career counseling
- Improve school conditions for student learning
 - Prevention programs for bullying, drug/violence, dropout, suicide
 - Relationship building, hazing awareness, healthy lifestyle, student mentoring
 - Improve use of technology to improve academic achievement and digital literacy for all students.
- PD for educators to personalize learning and using technology
 - Increase access to high quality digital learning/satellite courses for rural/remote students

2024 BOOKKEEPERS CONFERENCE

Title III, English Language Acquisition State Grants

- Title III, Language Instruction Educational Program (LIEP)
 - FRIS Program Code 4909
 - Old name LIPLEP
- Title III, Immigrant Student Education Program (ISEP)
 - FRIS Program Code 4905
 - Old name IEP
- Purpose:
 - Support implementation of high-quality instructional programs for ELs that will help them obtain English proficiency, achieve at high levels in core academic subjects, meet IL learning standards, and graduate from high school prepared to enter college or career
 - Provide professional development and training to teachers and administrators designed to improve the instruction and assessment of ELs
 - Promote parental, family, and community participation in the EL's education

2024 BOOKKEEPERS CONFERENCE

Title III, English Language Acquisition State Grants

- Allowable costs: Supplemental items to enhance the education of multilingual learners. (Sprinkles on the donut)
 - Before and After School Programs
 - Summer Programs
 - Related instructional services (curriculum, technology, supplies)
 - Professional Development
 - Parent, family and community engagement activities
- Cannot purchase full meals for PD or for family engagement events
 - Light refreshments are allowed



How are they different?

- Title III, Immigrant Student Education Program (ISEP)
 - Eligible Students ages 3-21 not born in any of the 50 states and Puerto Rico, and
 - Have been attending schools in the U.S. for less than three full academic years
- Title III, Language Instruction Education Program (LIEP)
 - Required activities
 - Supplemental Language Instructional Activities
 - Professional Development Activities
 - Family Involvement Activities



Individuals with Disabilities Education Act (IDEA)

- Multiple grants under the IDEA umbrella
 - IDEA, Part B Flow Through
 - IDEA, Coordinated Early Intervening Services (CEIS)
 - IDEA, Preschool
 - IDEA, Room & Board
 - FRIS Program Code 4625
 - Reimbursement based on students residing at a separate facility
 - No application or expense report is filed through the business office



IDEA Part B Flow-Through

- FRIS Program Code 4620, Subcode 00
- Purpose: Provide supplemental funds to ensure that all children with disabilities ages 3 through 21 receive a free appropriate public education in the lease restrictive environment.
- Allowable costs salaries for staff providing special education services including teachers, aides, administrative staff, social workers, psychologists, physical therapists, training, specialized consultants, instructional supplies, materials, and equipment.
- Maintenance of Effort (MOE) must spend as much per student as you did in the prior year

2024 BOOKKEEPERS CONFERENCE

Coordinated Early Intervening Services (CEIS)

- FRIS Program Code 4620, Subcode El
- Background used to be included with IDEA funds, with a percentage supposed to be spent on CEIS. Tracking and auditing became difficult and ISBE separated it out.
- Purpose to develop and implement services for students who are currently not identified as needing special education. The rationale is based on research that the earlier a child's learning problems or difficulties are identified, the more quickly and effectively the problems and difficulties can be addressed.
- Allowable costs PD, educational and behavioral evaluations, interventionists, tutoring for nondisabled students who score below "basic."



IDEA Part B Preschool

- FRIS Program Code 4600
- Purpose: Provide funds to ensure that all children with disabilities ages 3 through 5 receive a comprehensive special education program.
- Allowable costs employ staff, supplies/materials



School Nutrition Programs

- Illinois Free Lunch and Breakfast Program State funded
- Fresh Fruit and Vegetable Program Federal
- National School Lunch Program (NSLP) Federal
 - After-School Care Program
- National School Lunch Program Equipment Federal
- School Breakfast Program Federal
- Special Milk Program Federal
- Summer Food Service Program for Children Federal



School Nutrition Programs

- Programs are primarily run by a separate department or a third party
- NSLP Equipment Grant is the only one that needs a separate application in IWAS
- Money comes through as a per meal reimbursement
- Verification procedure for eligibility
- Eligible districts can apply for a Community Eligibility Program (CEP)
 - No charge to any student for meals
 - Reimbursement is based on community poverty levels



Education Stabilization Funds (ESF)

- Three Separate Awards Provided Under the Elementary and Secondary School Emergency Relief Fund (ESSER)
 - ESSER I (CARES Act)
 - Available for obligations through September 30, 2022
 - ESSER II (CRRSA Act)
 - Available for obligations through September 30, 2023
 - ESSER III or F (ARP Act)
 - Available for obligations through September 30, 2024
 - Subprograms
 - Each subprogram has its own funding requirements and compliance requirements

Emergency Connectivity Fund (ECF)

- What is the Emergency Connectivity Fund?
 - Program established through the American Rescue Plan Act of 2021 to provide schools and libraries the opportunity to purchase eligible equipment and/or advance telecommunications and information services during the pandemic.
 - Administered through the Federal Communications Commission.

Emergency Connectivity Fund (ECF)

- Emergency Connectivity Fund Waiver
 - Waiver approved in August 2023
 - Provided a one-time extension of the invoice filing deadline for applicants and service providers

Best Practice Tip #1 - Collaboration

- Routine grant meetings throughout the grant cycle
 - Teaching and Learning
 - Business Office
 - Departments spending the money
 - Nutrition Services
 - Buildings and Grounds
 - Principals
- Exchange copy of Budget Detail
 - Make sure employees are coding correctly
 - Check for any new account codes needed



Best Practice Tip #2 – Start Reports Early

- Most grants have a reporting requirement of at least quarterly
- Plan on needing time for review and making journal entries
 - Collaboration with grant writers
- Triple check to make sure your reports are filed
 - Many quarterly reports are being filed late



Best Practice Tip #3 – Account Coding

AA-BBBB-CCC-DD-EEEE-FF

A = Fund

B = Function

C = Object

D = Location/Building

E = Grant/Funding Source

F = Grant Year
