



RELEASE AND WAIVER OF LIABILITY

PLEASE READ THIS DOCUMENT CAREFULLY. BY SIGNING IT, YOU ARE GIVING UP LEGAL RIGHTS.

In consideration for being permitted to participate in the Yoga classes offered by Hello! Las Vegas Destination Management and ILTA in association with the 2015 ILTACON being held at Caesars Palace from August 31-September 3, activities related thereto, and access to the activities collectively, the undersigned hereby agrees as follows:

- 1. ASSUMPTION OF RISK: I am voluntarily participating in the activities offered by Hello! Las Vegas Destination Management, Inc. and ILTA, I assume, on behalf of myself, all risk of personal injury, death or disability to me that might result from said activities, or any damage, loss or theft of any personal property which I may incur while participating. I have been advised that it is strongly recommended that individuals with prior injuries or Health Conditions not participate in this activity. I have not had such prior injuries or Health Conditions or not withstanding this advice, I have decided to participate in the activities of my own free will. I understand and accept the above risks of bodily injury related to the activities.

- 2. RELEASE OF LIABILITY: On behalf of myself and my personal representatives, successors, heirs, and assigns, I expressly release and discharge Hello! Las Vegas Destination Management, Inc. and ILTA and its affiliates, instructors, officers, managers, agents, employees, clients, end-clients, participating venue, and members, as well as the owner of the real property where the activities are conducted, and the owners, manufacturers and installers of the equipment used in the activities (collectively, the "Released Parties") from any and all liability, claims, demands or causes of action whatsoever arising out of any personal injury, disability, or death, and any damage or loss to me, while participating in any of the activities. This release is valid and effective whether the damage, loss, injury or death is a result of any act or omission on the part of a Released Party or from any other cause. This Waiver and Release of all liability includes, without limitation, injuries, illness, accidents or loss which may occur as a result of (a) engaging in any activity; (b) use of the facility; (c) strenuous bodily movement; (d) exposure to extreme conditions; (e) maintenance of the equipment; (f) a malfunction of any equipment; (g) instruction or supervision; or (h) slipping and falling while in the facility or on the surrounding premises. I understand that I voluntarily give up any claims I may have, now or in the future, against the Released Parties, as well as my right to sue the Released Parties.

I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS RELEASE AND WAIVER, AND FULLY UNDERSTAND THAT IT IS A RELEASE OF ALL LIABILITY AND A WAIVER OF ANY RIGHT THAT I MAY HAVE ON BEHALF OF MYSELF AND/OR MY CHILD/WARD TO BRING A LEGAL ACTION OR ASSERT A CLAIM FOR INJURY OR LOSS OF ANY KIND AGAINST THE RELEASED PARTIES, EVEN A CLAIM BASED ON THE ACTIVE OR PASSIVE NEGLIGENCE OF ONE OR MORE OF THE RELEASED PARTIES. IF ANY ATTEMPT FOR CLAIM IS MADE, I UNDERSTAND I WILL BE RESPONSIBLE FOR INDEMNIFYING OR PAYING ALL LEGAL FEES OF THE RELEASED PARTIES' ATTORNEYS, IN ADDITION TO OTHER DEFENSE COSTS INCURRED BY THE RELEASED PARTIES.
