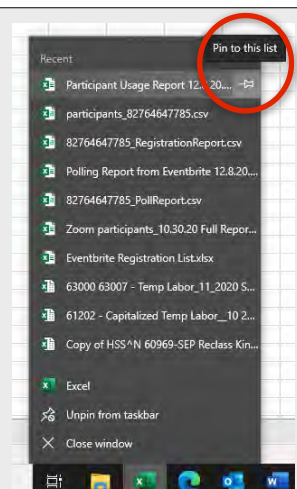
Excel-erate your Excel

Career Spotlight: Forensic Accounting

Many of us have heard about forensic accounting but are not familiar with what it takes to work in the field. In this article, Larry Vigna, takes us through his journey in the field, specifically working with the Federal Bureau of Investigation.

Q - What is a forensic accountant's role and how does it differ from a public accountant or a managerial accountant?

A - In general, a Forensic Accountant is examining data to specifically identify any instances of fraud or waste and will normally be brought in when allegations of misconduct are identified. Cases in which a Forensic Accountant are used generally have a litigation aspect, and it's common for a Forensic Accountant to testify in court as an expert witness. Conversely, the role of a public accountant (speaking in an audit setting) is as an independent third party to opine on whether the information presented in the financial statements is presented fairly and is free of material misstatement.



Q - What does a typical work week look like for a forensic accountant?

A - The answer is, there is no typical work week! The role of a Forensic Accountant is fast-paced and ever-changing based on the cases we work. In our capacity, regular work activities include examining voluminous financial and business data, performing research on subjects and subject businesses, participating in interviews, attending meetings with the investigative team and/or prosecutors, and writing reports based on the results of our examination.

Q - Does your job require a specific degree, certification (e.g., CMA, CPA, CFE...), or list of skillsets?

A - We do require an accounting degree and look for candidates with strong oral and written communications skills and strong computer and "data-mining" skills, especially in Excel. Many of the candidates I've currently seen apply for the position have a master's degree and one or more professional licenses including CPA, CFE and CIA. The FBI Forensic Accountants are the financial "experts" and the degree(s) and license(s) add that credibility when we testify in court.

Q - What advice would you give to students who wish to pursue a profession in forensic accounting?

A - The FBI looks for candidates with an accounting degree and at least 2+ years of professional work experience. If you are in school currently, DO AN INTERNSHIP!!! Many internships could lead to a permanent job after graduation, building your resume and professional work experience. The FBI loves candidates with public accounting experience, including audit and tax, as well as banking or securities investigations experience. Focus on education, experience and obtaining a professional license.

The FBI's Forensic Accountant Unit posts quarterly for external candidate applications on FBIJOBS.GOV. Information about FBI internships and other FBI career opportunities can also be found on this website.

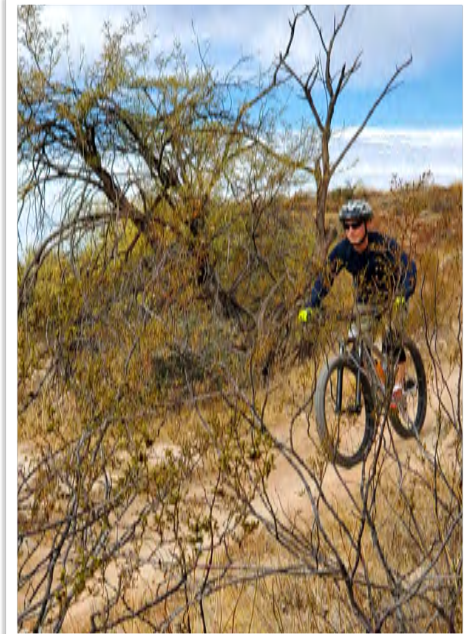
Off the Balance Sheet

I started getting more into mountain biking about a year and a half ago when my wife and I moved to a new house near the McDowell Mountain Preserve in Fountain Hills, AZ. Now, in less than five minutes, I can be out in the middle of a vast ocean of cactus, creosote bushes and ironwood trees, with a breathtaking view of the Four Peaks mountains.

One of the biggest lessons I have learned is that a mountain biker must be able to plot a path directly in front while simultaneously focusing on the path ahead. Beneath you are rocks, dips, and often loose sand and gravel requiring you to shift and brake accordingly. However, it is also imperative to be looking ahead at bigger obstacles, like drops or oncoming bikers. Learning to function in these two dimensions is something I find requires constant attention.

I believe this phenomenon is analogous to my role in accounting as well. As a supervisor, I need to make sure my team's day-to-day processes are running smoothly to avoid any obstacles that could derail us from our short-term goals. However, I also need to be looking ahead for those obstacles that could jeopardize our achievement of long-term goals such as reducing our month-end close or streamlining procedures.

If I focus all my attention on the daily “rocks” my team encounters, I will most likely lose sight of the long-term.
