#### CMA (Certification in Management Accounting)

The CMA Exam consists of two parts.

Each part is 4 hours and consists of 100 multiple-choice (3 hrs.) and 2 essays (1 hr.).

Test windows: January/February - June/July - September/October

### CSCA® (Certification in Strategy and Competitive Analysis)


