

"The Crypto Story"

If you're a skeptic, this upside-down world is just a modern Ponzi scheme that's going to end badly—and the recent "crypto winter" is evidence of its long-overdue ending. But crypto has dug itself into finance, into technology, and into our heads. And if crypto isn't going away, we'd better attempt to understand it.
