CPE Requirements

Below is a summary of the continuing education requirements for CMA and WI CPA licensure. To stay up to date on the requirements or to obtain greater detail, please visit the respective websites.

CMA CE:

- At least 30 CPE hours per year
- Period begins 1/1/20 and closes 12/31/20
- · Of the 30 hours, 2 hours on the subject of ethics
- If you complete more than 30 hours in a given year, up to 10 hours may
 be carried forward to the next year. If you complete more than 2 hours of
 ethics in a given year, up to 2 of the 10 carry forward hours can be ethics
 hours carried forward to the next year.

WI CPA CE:

- At least 80 CPE credits every two years
- Period begins 12/14/19 and closes 12/14/21
- At least 20 shall be completed during each 12-month period
- Of the 80 credits, not less than 40 credits from formal learning activities and include 3 credits on the subject of ethics
